Pension application of William Carraway (Caraway) R1725 Elizabeth f40SC Transcribed by Will Graves 5/23/11: rev'd 6/8/19

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia County of Monroe}

On this fourth day of September 1827 personally appeared in open court (being a court of record for the County aforesaid, William Carraway, resident in said County, aged seventy-three years, who being first duly sworn, according to law, doth on his oath make the following declaration, in order to obtain the provision made by the acts of Congress of the 18th of March 1818 & 1st of May 1820: That he, the said William enlisted for the term of 18 months, in the year 1778 or 1779, in the State of South Carolina, in the company commanded by Captain John Moore, in the Regiment commanded by Colonel John Beway [John Buie], In the brigade commanded by Brigadier General Andrew Williamson, in the line of the State of South Carolina, on the Continental establishment: that he continued to serve in the said Corps, as a Sergeant until the time for which he enlisted, had expired on the 11th day of June 1780, when he was honorably discharged from the service, at White Hall, in the State of South Carolina: that he hereby relinquishes every claim whatever to a pension except the present: that his name is not on the roll of any State, except South Carolina: & that the only reason why he has not made an earlier application are that he is ignorant, & that being aged, infirm & poor, he sees no company, & very seldom leaves home, & did not know until very lately that he was entitled to a pension.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

Schedule of property of William Carraway

3 cows & 2 calves worth \$36

a small quantity of household & kitchen furniture worth \$40

I have had no other property than that above stated since the 18th of March 1818.

Sworn to & declared on the day of 1827 before

I am a farmer and have no other trade or profession

The infirmities of old age have been increased by a severe injury from a hand spike & I am not able to labor.

My family consists of my wife, aged sixty-three years, & more infirm than myself: my

son Charles, aged twenty-three years subject to fits, which have impaired his understanding: he has no property, & is not able to maintain himself: my daughter, Mildred Launders, ¹ a widow, & owns no property but a bed: & my wife's sister Winnefred Averea, who is blind & owns no property.

Since the 18th of March 1818, I have always been about as poor as I now am, & their have been no changes in my property.

Georgia Upson County: Personally came before me a justice of the Inferior Court for said County & State William Carraway a Revolutionary Soldier and after being duly sworn saith on oath that the name of the commanding officer who commanded the Battalion in which he served in Colonel Huger's Regiment is & was at the time of service ___ Buie and that deponent is informed and believes a mistake was made in his petition heretofore made to be placed on the pension list, in the name of said Buie, spelling his name by mistake "Beway." On this 29th day of August 1832 personally appeared in open Court before Christopher B Strong Judge of the Superior Courts of the Clement Circuit and County of Upson and State of Georgia aforesaid William Carraway a resident of the County of Upson & State of Georgia aged seventy-eight years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the Benefit of the act of Congress passed June 7th 1832, that he entered the service of the United States under the following named Officers and served as

herein stated.

That he entered the service as a Private in Cambridge South Carolina in March or April 1778 under Captain John Moore of the 3rd Company was attached to Colonel Haigee's [? Hugee?] Regiment, that he remained a member of the said Company twenty months when he received a discharge³ from Captain John Moore which is now in the Pension Office Washington City that he was engaged as Orderly Sergeant [paper compromised and word or words illegible] Siege of Savannah under Captain Smith, that he was a resident of Cumberland County North Carolina when he entered the Service, that he was in the Battle of Stono, and that he knew General Lincoln of the Regular Service. He hereby relinquishes every claim whatever to a Pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.



[p 16: On July 12, 1856, in Upson County Georgia, John Caraway filed an affidavit stating he is the son of William Caraway, a revolutionary war pensioner; that his father died in Upson County Georgia February 1, 1834 leaving a widow surviving; that his parents intermarried previous to the 11th day of June 1780; that his mother Elizabeth died January 1, 1838 leaving him as heir at law.



[Veteran was pensioned at the rate of \$90 per annum commencing March 4th, 1831, for 18 months service as a Sergeant in the South Carolina militia.]
