Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Pension Office May 22, 1848

I certify that I have examined the case of Andrea Rey, deceased, who was a Surgeon in the Virginia State Troops, and I find that he served to the 14th of April 1783. The claim is therefore provided for by the act of July 5, 1832. The amount is payable at the rate of \$182.50 per annum from the 14th of April 1783 to the 1st of January 1793, in which year Rey died. William W Carraway, of Prince and County, Virginia, is administrator, and is now present to receive the money.

I certify that I have examined the claim of the legal representative of Doctor Andrew Rey, deceased for a balance of half pay under the act of the 5th July 1832. – That I find that he was the surgeon of the Illinois Regiment until the 14th of April 1783. – That the Illinois Regiment was Infantry and that the half pay of a Surgeon of Infantry was \$360 per annum. That in the allowance heretofore made, on the 22nd May last, only \$182.50 per annum was allowed. That there is consequently yet do \$172.50 per annum – from the 14th of April 1783 to the 1st of January 1793 and in which year Rey died and that the amount is payable to William W Carraway the Administrator of his estate.
