An act for the Relief of William Biggs

Be it Enacted by the Senate and House of Representatives of the United States of america in Congress assembled that William Biggs of the State of Illinois be and is hereby authorised to enter three sections of land in quarter Sections of the lands subject to entry at private sale, in the Samgamon district in the Illinois in consideration of his services as a Lieutenant in the Regiment of the General George Rogers Clark which marched against and subdued the Posts of Kaskaskia and Vincennes [4 and 20 July 1778]

Personally appeared, Jacob Ogle adm'r of Wm. Biggs deceased, Nancy Biggs Widow of said
Wm. Biggs, Sam'l. Scott and Nancy his wife, William Scott (widower of Mississippi Biggs), Samson
Biggs [Sampson Biggs], Catey Ann Biggs, Wm. S. Calbreath and Jemima his wife, and Matthew Cox &
Henrietta his wife of the County of St. Clair & State of Illinois, were duly proven in open Court, to be
heirs at Law of William Biggs deceased, who was said to be a Lieutenant in the State of Virginia on the
continental Establishment in the Revolutionary War, and it was furthermore proved, that the said Wm.
Biggs died in the year 1827 in the month of march in the Count of Madison and State of Illinois and they
pray the same be spread on the records of this Court.

Sir, Congress Hall 6th April 1816

Mr William Biggs of the Illinois Territory during this session of Congress have transmitted me a petition, for compensation in Land for services rendered the U.S. & since, he was an officer under Gen'l. Clark when he took possession of Illinois, & Indiana Territory, I should be glad to know what capacity he acted in, and what provision was made by the Legislation of Virginia, in behalf of Clarks Regiment, any information on this subject will be thankfully received. I am respectfully/ your obt. Ser't.
