Pension application of John Clarke R1990 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

North Carolina, Macon County: December Term

On this 25th day of December personally appeared before the Justices of the County Court John Clark ^{Sen} a resident of Macon County and State aforesaid aged 69 years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th, 1832.

That he was substituted for his Father, John Clarke, in the Virginia Militia in the year 1778 under Colonel Arthur Campbell, Captain James Thompson, Lieutenant William Edmondson [possibly William Edmiston] – term 20 days – marched from Abingdon Virginia [illegible words—paper damaged] Cripple Creek to New River at Quaker Meadows – to Osborne's & [illegible word—paper damaged] discharged – entered again in 1780 – in October under Colonel A. Campbell, Captain James [illegible word – paper damaged] from Abingdon Virginia to Watauga [River] up Doe River over Yellow Mountain through Bright's Trail to the Catawba [River] thence to Gilberts Town Rutherford County North Carolina thence to the Cowpens South Carolina thence to Cherokee Ford on Broad River where information was received that Ferguson [Patrick Ferguson] was encamped on the Kings Mountain – marched immediately to Kings Mountain and attacked Ferguson in the evening of Saturday (date not recollect) [October 7, 1780] - William Campbell principal in command, Colonels Cleveland [Benjamin Cleveland], Sevier [John Sevier], Shelby [Isaac Shelby] & Williams [James Williams] present the last of whom was wounded and died next day about 4 or 5 miles from the battle Ground – marched [remaining text torn and missing at bottom of the page] plantation in Rutherford County and State of North Carolina, thence to Burke Court House – thence to Wilkes Court House and discharged term thirty days.

I hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the pension list of any State. Sworn to and subscribed the day and year aforesaid.
