## State of South Carolina Lexington District

On this second day of August A.D. 1855 personally appeared before me James J Clark a Magistrate of said District Rachel Taylor formerly Rachael Clark before her marriage aged sixty-seven years, and who is physically unable to attend court being unable to leave home at this time who being duly sworn according to law makes oath and says that she is the child of Gregory Clark who was a Soldier of the American Revolutionary War that he performed service in said war for about 10 months as she is informed and believes and as appears from the Army certificate returned to the Treasury by the Sheriff of Randolph County and Hillsboro District North Carolina as appears by a certificate from the Comptroller of North Carolina here with presented. That her father Gregory Clark and her mother Lurany Parker were married in the year 1781 that he died January 1837, that she died June 1849, leaving Sarah intermarried with John Berry, Cornelius Clark, Parker Clark, Nancy intermarried with David Shots, Santee intermarried with Jacob Herrold, Catherine intermarried with David Herrold , Clarissa intermarried with Michael See and this deponent children of the said Gregory Clark and his wife Lurany Clark all of whom survived the said Gregory and Lurany & are now living (except Nancy who died previous to her father & mother).
