[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Revolutionary Claims

Treasury Department,

5 May 1829

George H Blaylock of ___ in the County of Logan in the State of Ohio has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Sergeant in Captain Lytle's Company, in the ___ regiment of the North Carolina line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing


The records of this office do not show that George H Blaylock of the North Carolina line ever received or is entitled to bounty land of the United States.

For the purpose of obtaining the benefit of an act for the relief of certain surviving officers and soldiers of the Army of the Revolution, approved on the 15 May 1828,, I George Henry Blaylock, generally known by the name of George Blaylock of the County of Logan in the State of Ohio do hereby declare that I enlisted in the Continental line of the Army of the revolution for and during the early War, and continued in its service until its termination at which period I was a Sergeant in Captain William Lytle's (or Little's) company in the ___ Regiment of North Carolina line – that was commanded by Colonel Archibald Lytle (or Little) and that I also received a certificate for the reward of \$80 to which I was entitled under a resolve of Congress passed 15 May 1778. –

And I further declare that I never was on any pension list of the United States

Before me Justice Edwards a Justice of the Peace in the County of Logan in the State of Ohio came this day the within named George Blaylock and made oath that he was discharged from the Army of the Revolution at James Island Ashley River near Charleston South Carolina – after the close of the war – when he returned to Chatham County in North Carolina, where he enlisted – where he lived upwards of 30 years and removed to Ohio 26 years ago – that he preserved his discharge until the 1st taking of Fort Meigs after the surrender of General Hull when said Blaylock lost all his property and his discharge with it – he then moved to this County and has remained here ever since. Witness my hand & seal this 18 April 1829
