Revolutionary Claims

Treasury Department, 6 January 1829

Torrence Curry, of Sparta in the County of Dearborn in the State of Indiana has applied to the Secretary of the Treasury for the benefits of the act, entitled "An Act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the army of the Revolution, for and during the war, and continued until its termination, at which period he was Private

in captain Taylor's company, in the regiment of the Virginia line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th day of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3d of March, 1826, nothing.

The Third Auditor is requested to report how far the several statements corroborated by the records in his office.

For the purpose of obtaining the benefits of the act entitled "an act for the relief of certain surviving officers and soldiers of the army of the revolution." approved on the 15th day of May 18. 1828, I Torrence Curry of the township of Sparta in the County of Dearborn in the State of Indiana do hereby declare that I enlisted in the Continental Line of the army of the Revolution for and during the war, and continued in its Service until its termination; at which period I was a private in Capt. Taylor's Company of the 4th Regiment of the Virginia Line on the Continental Establishment But the name of the Colonel who commanded the Regiment I do not now recollect. And I do also declare that I was afterwards received certificates for the reward of Eighty dollars to which I was entitled under an act of Congress Passed the 15th day of May 1778.

And I further declare that I was not on the 15th day of May 1828 on the pension list of the United States.
