Pension application of Alexander Gorden (Gordon) R20375 Transcribed by Will Graves f19SC 9/21/08 rev'd 9/11/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Revolutionary Claim Viz for the purpose of obtaining the amount of pay accruing to me for the half-year Ending on the 2nd day of September 1828 Under the Act entitled for the relief of certain surviving Officers and Soldiers of the revolution approved the 15th May 1828 I Alexander Gorden of the County of Robertson and in the State of Tennessee do hereby declare that I was a Soldier Enlisted for three years Served in the first Regiment of South Carolina under Felix Warley Captain & Pinckney General, being an Army of the Revolution in the Continental line as it is more fully set forth in my application for the benefit of said Act and that I have been found entitled by Secretary of the Treasury Under that Act to the pay of a Soldier in said line. Witness my hand this the 25th day of October in the year of 1828.

[James Doss and Andrew Washington gave an affidavit as to the Gorden's reputation for having been a revolutionary soldier.]

Sir I received your advices dated December 22nd, 1828 (which informed me that my declaration was not fully specific enough to draw my pay under the Act of May the 15th 1828) hereby agreeable to your advices make this part of my Declaration to be annexed to my former [declaration] I first declare I was Enlisted by Captain Martin and it was for and during the war and served under Captain Felix Warley until its termination in the first South Carolina Regiment Commanded by General Pinckney in the Continental line at which time I was honorably discharged by said Warley my discharge is lost or mislaid so that I cannot send you the same But I have a certificate for the Land I was to draw which I have never drawn as yet which I will send to you for further proof unto which you will enclose the same & send to me again I also declare to the Best of my knowledge that I did receive Certificate for the reward of \$80 under the resolve of Congress passed the 15th of May 1778 and I further declare that I was not on the pension list of the United States on the 15th of May 1828 as witness my hand This 24 February 1829.



Alexander Gordon of __ in the County of Robertson in the State of Tennessee has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain Warley's Company, in the first regiment of the South Carolina line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

The Third Auditor is requested to report how far the several statements are corroborated by the records in his Office.
