[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefits of the act entitled "And Act for the relief of certain surviving officers and Soldiers of the Revolution" approved on the 15th May 1828, I Edward Newton of the County of New Hanover in the State of North Carolina, do hereby declare that I entered in the Continental line of the Army of the Revolution in and during the War and continued in its service until its termination at which period I was a private in Captain Raiford's [Robert Raiford's] Company in the 1st Regiment of the North Carolina line –and I also declare that afterwards I received certificates for the reward of Eighty Dollars to which I was entitled under the Resolution passed by Congress 15th May 1828.

Personally appeared before me Joseph Lamb [?] one of the Justices of the Court of Pleas & quarter Sessions Samuel Vines¹ & John Vines² and maketh oath that they are personally acquainted with Edward Newton of said County, & that they know he was a private Soldier in the North Carolina line, of the Army of the Revolution and that the said Edward Newton belonged to Captain James Mills Company & served until the end of the War, and belonged to the same company with these deponents.

I William Hill Secretary of State in and for the State aforesaid, do certify, that it appears from the musterrolls of the Continental line of this State in the revolutionary war, that there were two persons of the name of Edward Newton who served as soldiers in said line, and that they stand on said Rolls as follows, Viz.: "Edward Newton a private in Captain Mills's Company of the 10th Regiment enlisted on the 7th day of February 1782 for the term of 12 months." "Edward Newton a private in Captain Brevard's Company of the 10th Regiment enlisted ___ 1782 for 18 months and died the 25th June 1783," and that nothing further is said of either of them on said Rolls.

I do further certify that it appears from a Book in this Office called, "the Warrant Book,"

in which an account is kept of the Warrants issued to the Officers and soldiers of the line aforesaid for services performed therein, that a Warrant was issued on the 26th May 1784 for the service of Edward Newton a private Soldier in the line of this state for 640 Acres of land, the quantity allowed by law to Soldiers who served during the War or to the heirs of such as fell in service of their Country, which said Warrant was issued on the certificate of a field Officer previous to the muster rolls being deposited in this Office.
