Ontario County On the Fourth day of May in the year of our Lord One Thousand Eight Hundred and Eighteen before me Timothy Barnard one of the Judges of the Court of common pleas of the County of Ontario in the State of New York, personally appears Charles Close aged Sixty One Years Resident in the County and State aforesaid who being by me first duly sworn according to Law doth on his Oath make the following Declaration in Order to Obtain the provision made by the Late Act of Congress "Entitled an Act to Provide for certain Persons engaged in the Service of the United States in the Revolutionary War That he the said Charles Close Inlisted in or about the month of November in the year one thousand seven hundred and seventy five at the city of Baltimore in the State of Maryland in the company of Capt. Nathaniel Smith belonging to the Artillery (The Colonel's name the Deponent does not at this time recollect) in the Maryland Line and that he continued to serve in said Corps about two years at which time he was transfered to Capt. Lansdale's company commanded by Col. Samuel Smith in whose he continued to serve four years at the end of which time he was discharged in the City of Baltimore and that the Deponent was during said service in the Battle at Monmouth in New Jersey [28 Jun 1778] and in the Battle at the Cowpens [17 Jan 1781] next[?] at the Battle at Camden [either on 16 Aug 1780 or Battle of Hobkirk Hill on 25 Apr 1781] next at the Battle at Guilford Court House [15 Mar 1781] and also at the takeing of Lord Cornwallace [sic: Cornwallis; 19 Oct 1781]; and that he is in reduced circumstances and stands in need of the assistance of his Country for support, and that he has no other evidence now in his power of his said services ~ Mark Chre

## STATE OF NEW YORK, ONTARIO COUNTY, SS.

On this tenth day of November 1820 personally appeared in open Court, (being a Court of Common Pleas in and for said county, and constituted a Court of Record by proceeding according to the course of the Common Law, with a jurisdiction unlimited in point of amount, and keeping a record of its proceedings, and recognized as such Court by the laws and judicial decisions of said State,) Charles Cloes aged near Seventy years, resident in the town of Penfield in said county, who, being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War as follows: that he enlisted in December 1776 in Capt'n. Nathaniel Smith's Company of artillery stationed at Whitstown point, for three years, served out his time and re-enlisted in Capt'n. Landsdale's Company in the 4<sup>th</sup> Maryland Regiment commanded by Col. Sands Smith [sic] where he served until the Capture of Cornwallis and was then honorably discharg'd

and that he made application for a Pension on the fourth day of May 1818 and that he received a Pension Certificate, No. 17.278 And I do solemnly swear that I was a resident citizen of the United States on the eighteenth day of March, one thousand eight hundred and eighteen, and that I have not since that time, by gift, sale, or in any manner, disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War," passed on the 18th day of March, 1818, and that I have not, nor has any person in trust for me, any property or securities, contracts, or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed, and by me subscribed, viz.

And I do further swear and declare, that I am by occupation a farmer, but that owing to extreme bodily infirmity (being crippled) I am unable to do labor of any kind, and that my family consists of my wife aged fifty three years, my Son James aged twenty years, my daughter Clara aged fourteen years, my son Charles aged eleven years, and my daughter Caroline aged nine years. I hereby certify, that it appears from the muster-rolls remaining in the Auditor's Office, that Charles Close enlisted as a pvt. in the 4<sup>th</sup> Maryland Regiment, on the 3<sup>rd</sup> day of April 1778 and was on the 1<sup>st</sup> Nov'r 1780 present

NOTE: On 16 June 1846 Nancy Ray of Monroe County NY, daughter, applied for a pension in her own behalf and that of Charles and Hannah Cloes's other six children: Sally Andrus, Hannah King, Qurella Gregory, Caroline Cloes, O'Neil Cloes, and Charles Cloes. She stated that her parents were married in Balstown [Ballston?] NY in 1784, that Charles Cloes died in Webster in Monroe County on 10 Sep 1838, and her mother died there on 23 June 1842.
