Pension application of Charles Coleman R2155 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the

software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my

State of South Carolina Fairfield District: SS: Ordinary Office

On the 11th day of July 1855 before George W Woodward Ordinary for Fairfield district and State aforesaid personally appeared James B Coleman aged 55 years and upwards a native born citizen of said district and State who being duly sworn according to law declares that he is the oldest surviving child of Charles and Ruth Coleman deceased late of this District and State aforesaid. That his said father Charles Coleman was a Soldier of the Revolutionary war and therefore makes this declaration for the purpose of recovering the arrears of pension due for his father's Services in said war, under the act of Congress of 7th of June 1832 for the benefit of himself and his surviving Sisters and Brothers children of his said parents; that from conversations and remarks made by his said father Charles Coleman he understood and believes he served in the Army of the Revolution and was at the Battle of Gates defeat Camden South Carolina [August 15-16, 1780] from which he made his escape with a wagon and horses belonging to Declarant's Grandfather and Mr. Stephens the Uncle of his said father Charles Coleman; that his Grandfather Cader Coleman, James Rutland and William Moon were also in said battle of defeat at Camden aforesaid; and that the declarant's Grandfather Abraham Gibson with four of his Brothers also served in said war – having often heard his said father, Grandfathers – Mr. Rutland and Mr. Moon refer to their services in the Revolution, that this Declarant knows his said father Charles Coleman was by trade a blacksmith and well acquainted with repairing Guns, could temper steel and has seen him make Gunlocks; that he believes his said parents Charles and Ruth Coleman were married about the year 1796 or 1797; that his said mother Ruth Coleman, whose name before marriage was Ruth Gibson departed this life in 1825 and his father Charles Coleman on the 6th day of April 1842 as recorded by this Declarant in his family Bible a few days after his death leaving the following named Surviving children, (his Sister Harriet M Coleman who was about two years older than this Deponent – having died two years subsequent to his said father) namely this Declarant the said Harriet M Coleman wife of M. A. M. Leggo deceased, Melinda W Keith, Charles S Coleman, Joseph D Coleman, Judith B Simpson, Sarah Ann Simpson, Jane B Smith and John A. J. Coleman, all of whom now Survived except the said Harriet M Coleman wife of M. A. M. Leggo as aforesaid; that the death of his said father was recorded by Declarant as aforesaid, and also that of his oldest Sister Harriet oldest child of his said parents, belief of said record being hereunto appended: This deponent further declares that he is the only surviving Executor under the last will and testament of the said Charles Coleman's Estate.


