## Pension application of John Hill R21669 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee, County of DeKalb

On this 3<sup>rd</sup> day of August 1846 personally appeared before the County Court of DeKalb County now sitting John Hill a Resident of DeKalb County and State aforesaid aged Eighty one years the 25<sup>th</sup> of the present Instant who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832. That he volunteered in the Service of the United States in Richmond County State of North Carolina in October 1780 for three months under Captain William Wall commanded by Colonel Thomas Crawford in pursuing the Tories who were murdering and plundering the inhabitants in various parts of North and South Carolina part of his time in pursuing Colonel Fanning [David Fanning] Col. Elrod [John Elrod] and Captain McCoy the officers and leaders of the Tories as they was called at that time he was at the skirmish at the Shoe Heel one near Little Pedee in South Carolina and one at Betties Bridge [August 4, 1781] on Drowning Creek North Carolina when General Wade [Thomas Wade] was defeated by Hector McNeal [Hector McNeill] the Tories' Commander besides great many small engagements not at present recollected and was on the Adkin [sic, Yadkin River], Rocky, Deep and Cat Fish rivers through various parts of them constantly volunteering at different time his time when his time would expire and serving in all Twelve months until the surrender of Cornwallis at Little York and was discharged at Rockingham Richmond County North Carolina by Colonel Thomas Crawford and retired from service the declarant was not acquainted with the officers of regiments as he was not with the Main Army he further asserts that he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to his service also the Cause of his not making earlier application for a pension was that he never would apply until he has become old and unable to labor for his Support of late years and being in indigent circumstances. He hereby Relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State. Sworn to and subscribed the day and year aforesaid.

department doth Reply to Question 1 that he was born in Richmond County State of North Carolina in the year 1765. Answer to Question 2 he has a record of his age but it is in his Mother's Bible in the State of Alabama. Answer 3 when called into service he lived in Richmond County North Carolina since the Revolutionary War he lived upwards of 10 years in North Carolina and upwards of 25 years in South Carolina and 32 years in the State of Tennessee and continues to live in Tennessee Question 4<sup>th</sup> he volunteered at different times under Captain William Wall and Colonel Thomas Crawford in pursuit of the Tories in retaking of plundering property from them Answer to Question 5<sup>th</sup> he was not acquainted with any officers of regiments as he did not belong to the Main Army. Question 6<sup>th</sup> he Received a discharge from Colonel Thomas Crawford and brought it with him to Tennessee and it has been carelessly lost or mislaid that he can't find it. Questions 7<sup>th</sup> as to his character for veracity and their belief of his service in the Revolution he would refer to Pleasant A. Tomkinson [?] former Sheriff of DeKalb County John Allen the present Sheriff John A. Fusion his member to the State Legislature and Captain Bernard Richardson.
