Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Tennessee County of Decatur

On this 1<sup>st</sup> day of January A.D. 1855 personally appeared [before] me Samuel Brashears Chairman of the County Court of County and State aforesaid Rachel Conrad, a resident of the County of Decatur in the State of Tennessee aged Sixty Seven years who being first duly sworn according to law, doth, on her oath, make the following declaration, in order to obtain the benefits of the provision made by the act of Congress passed on 3rd February 1853, granting pensions to widows of persons who served or in the Revolutionary war, that she is the widow of David Enoch who was a private, and as she believes was mustered into said Service in the County of Caswell in the State of North Carolina, but served some portion of his time in the State of South Carolina. But as to the time of entering the said Service and being discharged therefrom, and the length of time he continued therein, She must refer to the Records of the war department, the muster rolls, and the accompanying Certificates of his Officers.

She further declares that she was married to the said David Enoch the month of October 1803, in the County of Caswell in the State of North Carolina by a certain Nathan Williams a Justice of the peace, and that her said husband died in the County of Smith in the State of Tennessee in the month of October in the year 1808. And that she was afterwards married to a certain Philip Conrad on the 17th day of April in the year 1814, and who died in the month of August 1837, That she was not married to said David Enoch prior to the Second day of January 1800, but the time above Stated. She further declares that she is now a widow.
