Pension application of Edward Couch R2359 fn23NC

State of North Carolina Orange County

On this the 29th day of May A.D. 1844, personally appeared before the undersigned one of the Justices of the Court of Pleas and Quarter Sessions of said County, Mary Couch, a resident of New Hope in said County, aged eighty-eight years, who being first duly sworn according to law, doth, on her oath make the following Declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th, 1836:

That she is the widow of Edward Couch, deceased of said County of Orange, who during the war of the Revolution, served the United States as hereinafter set forth:

1. The said Mary Couch Declarant as aforesaid, states upon her said oath that she has reason to believe and does believe that in the fall of 1778 there was a draft for Militia men to serve the United States a tour of five months, when the Declarant's husband the aforesaid Edward Couch was drafted for said tour.

The company to which said Edward Couch was attached was commanded, to the best of her recollection and belief by Captain Thompson – Lock was Colonel: said troops rendezvoused at Hillsboro in the aforesaid County of Orange, on or about the 15th day of October 1778, were marched to Salisbury, to Charlotte, thence to Purrysburg on the Savannah River, thence to General Rutherford's Camp – thence to the Cheraw Hills – and at the Cheraws was discharged and returned home, having served the United States in the above Tour of five months as a private of infantry in the militia.

Her deceased husband, she thinks had a discharge, but does not know what has become of it. In all of the above tour, the said Declarant has reason to believe that her Deceased husband was in a legally organized Corps, and called into service by competent authority: This tour the Declarant proves by the affiant John Dolley¹ whose affidavit is hereto annexed and marked "A."

2. The said Mary Couch Declarant as aforesaid, further states upon her said oath that, sometime in the fall of 1781, about three years after her marriage with said Edward Couch, there was a draft for militia men to guard the Town of Hillsboro in the aforesaid County, – the length of this service under said draft was three months – and the object of it was to guard the prisoners and military in said Town.

In this tour the aforesaid Edward Couch was in the Company commanded by Captain Lowe, ___ Taylor Colonel. This tour commenced a few days after Hillsboro was captured by the British and Tory forces under Colonel Fanning in September 1781 – about the 15 of September 1781 and terminated 15 December following: In duration three months. At the expiration of this tour, the said Edward Couch received a discharge from his Colonel (Taylor) but the Declarant does not know what has become of it. In all of the aforesaid tour of three months the said Edward Couch, served the United States, as a private of Infantry in the Militia.

In this tour the Declarant has reason to believe and does believe and does believe that her Deceased husband, the aforesaid Edward Couch was in a legally organized Corps, called into service by Competent Authority.

This tour is proven by the affiant James Riggs² whose affidavit is hereto annexed and marked "B."

She further declares that she was married to the said Edward Couch in the month of August 1778. That she has a "family Record" and is as follows, to wit:

"Edward Couch was born the 31st of July 1761 and married to Mary Whitworth the ___ day of"

(1st Child)-- "Elizabeth Couch daughter of Edward Couch and Mary his wife was born June 26 1779 (departed this life)"

that her husband the aforesaid Edward Couch, died on the fifth day of February in the year 1831, and that she has remained a widow ever since that period, as will more fully appear by reference to the proof hereto annexed.

The Declarant further states upon her said oath that from old age and infirmity of body is unable to attend Court to make this Declaration. And that during the revolutionary war she lived in the aforesaid County of Orange.

State of North Carolina Orange County

On this the 12th of September 1843 personally appeared before the undersigned one of the Justices of the peace in and for said County, James Riggs a resident of said County of Orange, aged 83 years, an United States pensioner, who being first duly sworn according to law states that sometime in 1781 there was a draft for three months militia man to joined General Butler's Army – about this time Colonel Fanning surprised & captured the Town of Hillsboro in the aforesaid County of Orange – a draft was had to raise men to guard said Town – when this deponent was drafted out of his Company to guard said town. That he entered upon this service as private of Infantry in a company of Militia under the command of Captain Lowe. Taylor was Colonel. Served in guarding said Town of Hillsboro as aforesaid from about the 15th of September 1781 to the 15th day of December following, being a three months tour of duty & was then discharged by Colonel Taylor.

In all of said tour, this deponent remembers that Edward Couch of the aforesaid County was a private of infantry in said Captain Lowe's Company & served all of said tour with us.

This deponent understands that said Edward Couch is dead, and that his widow Mary Couch is applying for a pension for the Revolutionary Services of said Edward Couch, and further this Deponent saith not.

State of North Carolina Orange County

On this the 28th of February 1844 personally appeared before the undersigned one of the

acting Justices of the peace in and for said County John Dolley a resident of said County and an United States pensioner who being first duly sworn according to law maketh oath that in the year of 1778 there was a draft for five months men when this affiant was drafted for and did serve all of said tour in the United Service.

This affiant states that on or about the middle of October 1778 said tour commenced. Thompson was Captain. Lewis was Colonel part of said tour, as was also Locke.

Rendezvoused in the Town of Hillsboro in the County aforesaid was marched to Salisbury, thence to Charlotte, to Purrysburg on the Savannah – and thence to Rutherford's Camp on Black Swamp – and at Cheraws was discharged and returned home in all of said tour this affiant remembers that Edward Couch of New Hope in the aforesaid County was a private of Infantry with this affiant, and was discharged at the expiration of said five months tour at Cheraw Hills as aforesaid and further this affiant saith not.
