Pension Application of Thomas Chandler R24

VA Sea Service/ Half Pay

Auditors Office [Richmond VA] May 27, 1846

Sir Yours of the 14 & 15 inst, were duly received and would have been sooner answered but for a great press of business.

The name of Robert Young cannot be found on any of the army rolls.

The name of Lieut. Thomas Chandler is found in the arrangement of the Navy which was made in 1781. We have no evidence that I can find how long he continued in service afterwards. The arrangement appears to have been before the council in May 1781 & there is opposite to his name the remark or note "since dead" – When the note was made or by whom does not appear.

I certify that I have examined the claim of the administrator of Thomas Chandler, deceased, and I find that under the act of July 5, 1832 half-pay was allowed for his service as a Lieutenant in the State Navy of Virginia from the 3<sup>d</sup>. of September 1783. Half pay is now claimed from the first of January 1782, and I am of the opinion that the claim should be allowed. I therefore certify that half-pay is still due for said Chandler's service at the rate of one hundred and eighty two dollars and fifty cents per annum from the first of January 1782, to September 3<sup>d</sup>. 1783, and that the amount is payable to the Honorable Thomas H. Bayly, of Virginia, attorney of John B. Ailworth, administrator of said Chandler. Approved/ Secretary of War commissioner of Pensions

[The following are from bounty-land records in the Library of Virginia. in two files]

These are to Certify that Leutenant Thomas Chandler enterd in the Navy of this state some time in May 1776 and that on or about July 1778 was appointed Leutenant and faithfully served until July 25<sup>th</sup> 1781 when he died a prisoner at Norfolk being some time before taken in the State Boat Patriot.

I do certify that the Representative of Thomas Chandler is entitled to the proportion of Land allowed a Lieutenant of the State Navy for three years service.

Richmond Apl 2<sup>nd</sup> 1831

To his Excellency John Floyd

Dear Sir By the enclosed papers you will see that the devisees of Lieutenant Thomas Chandler of the navy of Virginia in the revolution and entitled to the warrant for his military bounty land did not receive it. The only heir of Catharine Chandler the devisee is now the wife of John B. Burtin and they are in needing circumstances. And as she is entitled to the land [undeciphered word] & due for the services of her Uncle who devised it to her mother who has never received any part of the land bounty but has lost the 2666% acres, which was issued to her uncle Mitchell Chandler the oldest Brother who

was not entitled to it. I submit it to your Excellency whether it would not be equitable and just that this case should form an exception to the general rule not to issue an order for additional land bounty until those who have never received any should be first benifitted"

For the evidence of the service of Lieutenat Chandler I refer to the [undeciphered word] certificate that his pay has been settled and the certificate of the Register of the land office that a warrant for 2666% acres only to Mitchel Chandler for the service of Lieutenat Thos Chandler has been issued and the report of the bord of Officers of 1782 & 1784 that he served to the end of the war and was entitled to half pay. I also enclose to your Excellency the evidence of the services of Covington Broadwater [VAS668] a midshipman in the navy of Virginia in the revolution. viz The depositions of Scarborough Bloxum [W5842] and Elcanah Andrews [Elkanah Andrews S6507] and the certificates of the Auditor & Register. NOTES: With the pension application of William Saunders (R89) is a copy of "a paper to be found in 1st Vol of papers concerning the State Navy" entitled "List of Officers of the State Navy agreeable to the arrangement 13th May 1784." It lists Thomas Chandler as Lieutenant, "Dead."
