[p 4] State of Virginia, Grayson County

On this 24th day of September 1832 personally appeared in open Court, before the Justices of the Court of Grayson now sitting James Cox a resident of Grayson County & State of Virginia aged 69 years & 7 months, who being first duly sworn according to Law, doth, on his oath, make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States under Capt. John Cox at the age of 15 or 16 and assisted in building a fort on New River, near the mouth of Peach Bottom Creek, in the year 1778 and from that time until the year 1780 he acted as an Indian Spy for the said Capt. John Cox, and from his intimate knowledge of the Country, was upon every occasion sent as a pilot to conduct those who were unacquainted with the mountains, in safety to where the different parties had their encampments. The Tories about this time or about the time the British were invading North & South Carolina, became very troublesome in the Country where he was (having but very few neighbours who were not Tories) and those, with those of the adjoining State of North Carolina, would frequently assemble themselves & overrun the Country. The declarant's father, the aforesaid Capt. John Cox, Enoch Osborne & his family, Benjamin Phipps, Peter Hunt [could be Hart or Hout]¹, & William Hardin were the only Whigs who would render any assistance when required. In this situation, surrounded by Tories, the declarant and a few others had to combat the whole neighbourhood, and when they found themselves too weak [9 lines of text are crossed out and thereby rendered illegible although the name of John Cox can be made out twice in the lined out portion of the text], declarant was sent as an express to Col. Benjamin Cleveland who was stationed on the Yadkin River near where the town of Wilksboro [Wilkesboro] has been since built, to inform him of the fact that the Tories were collecting in large bodies in the mountains shortly after his return from Col. Cleveland's camp he was taken prisoner by the Tories who intended to take & deliver him to the British, but in the meantime Col. Cleveland and Major Love had joined their forces and overtook the Tories at a place called the big glades [Big Glades, also known as the Battle of Round Meadow according to Lyman Draper occurred in July 1780, now in Grayson County Va [some say this engagement occurred in the adjoining County of Ashe in North Carolinal. The Tories when they discovered the Whigs determined to seek safety by flight and in their terror forgot the declarant who availed himself of the opportunity and immediately run with all speed to the Whigs and informed them of what the Tories had done, the Whigs then pursued them, wounded some and took others prisoners whip'd or flogged several severely, & hanged one man where the declarant now lives. After this the declarant's father Capt. John Cox being on an expedition against the Indians, the Tories under a Capt. Green made another ascension into the mountains and the declarant raised his father's Company and



pursued the Tories under Green, & killed & made prisoners of Green & his entire Company. Green afterwards died of his wounds, and only one of the said Company survived; this was a brother of the said Green, who afterwards enlisted in the Regular army of the United States. Sometime after this affair, a certain Capt. Roberts, of the Tory party, came into the neighborhood with a Company of Six Hessians, and this declarant with Major Love pursued them into Carolina near the head of New River, determined to overtake them, but Capt. Baker of North Carolina had heard of them, got in before the declarant & his party, overtook, killed & wounded the whole party except Roberts [probably John Roberts], their Capt., who made his escape. This declarant does not now recollect the precise time he was engaged in the War of the revolution, but he is very certain that he served under his father Capt. John Cox, and Major William Love, as an Indian Spy, for the term of 2 years and that he was engaged under the same officers, against the Tories for 2 years more making in all 4 years service. This applicant was born in Fort Chisal [Fort Chiswell, at the Chiswell Lead Mines now is Wythe County, Virginia], in the County of Wythe then Botetourt & afterwards Montgomery County Feby 24th 1763. He has a record of his age in a large family bible which was given to the declarant by his father. He lived in Montgomery County Virginia when he entered the service, now Grayson County Virginia where he has lived ever since the War of the revolution, and where he now lives. He was a volunteer during the whole service. There was no regular officers in the neighborhood. He never had any discharge, indeed his only wish was to conquer & subdue the enemies of his Country. He is known to Benjamin Phipps² & Isaiah Austin³ contemporary survivors and to John Jones & Charles Cole, who can certify to his character for veracity, and as to their belief of his services in the War of the Revolution. He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State. Sworn to & subscribed the day & year aforesaid.

We Benjamin Phipps residing in the County of Grayson and Charles Cole residing the same County, hereby Certify that we are well acquainted with James Cox, who has subscribed and sworn to the above declaration, that we believe him to be 79 [sic] years & 7 months of age; that he is reputed in the neighborhood where he resides to have been a soldier of the revolution, and that we concur in that opinion.

On this 24th day of June 1833, personally appeared in Open Court, before the Justices of the Court of Grayson County, now sitting, James Cox, an applicant for a pension under the Act of Congress passed June 7th 1832, and, being first duly sworn according to Law, doth, on his oath, make the following Amendment to his Original declaration made in this Court on the 24th day of September 1832, in Order to obtain the benefit of the Act of Congress passed June 7th 1832 as aforesaid. That he entered the Service of the United States as a volunteer in the year 1778 under the Command of Captain John Cox, who was ordered into Service by Colonel Walter Crockett of Montgomery County Virginia now Wythe County, and was in actual Service, against the Indians & Tories in the mountains of Virginia under the said Officers a tour of six months. In the year 1779 this declarant was again called

into Service as a volunteer under the same officers & was in actual Service a tour of six months, in pursuit of the Tories, in Virginia & North Carolina: and in the year following, 1780, he again went as a volunteer under the said Captain John Cox, who was then commanded by Major Love of Virginia & Colonel Cleveland of North Carolina and was in actual Service one month and 15 days, mostly all along the Virginia & North Carolina line. This applicant never had a discharge from the Service nor has he any documentary evidence of his Services. There being no clergyman residing in the neighborhood of this applicant, at the time of making his original declaration, and being advised that the officers of the War Department, probably would not require that the strict letter of the Law, in that particular, should be complied with, this declarant did not supply that; that would be ground of objection, and this is the reason why he did not obtain such affidavit. He now complies with the law in that particular.

Personally appeared before me, the undersigned, a Justice of the Peace in and for the County of Grayson, James Cox who being duly sworn deposeth and saith that by reason of old age and the consequent loss of memory he cannot swear positively as to the precise length of his service but according to the best of his recollection he served not less than the period mentioned below, and in the following grade: For one year, one month and 15 days I served as a volunteer; and for such service I claim a pension.

State of North Carolina, Ashe County: Court of pleas & quarter Sessions February Term 1835

Henry Hardin maketh oath that he knew James Cox of Grayson County Virginia who (as this affiant understands) has said in his declaration claiming a pension for services rendered the United States during the Revolutionary War – and that the said James Cox did serve under Colonel Cleveland & Captain Nall in several tours of service against the Indians and Tories – and that the said James Cox was taken prisoner by the Tories at one time-- this affiant has been acquainted with the said James Cox ever since, and knows well that he is the same and served as stated in his declaration.

This day personally appeared before me a Justice of the Peace for the County aforesaid Burwell Spence⁴ and made oath that he was at a Fort on New River at the mouth of Peach Bottom Creek as a

volunteer under Capt. John Cox & served in said Fort for some time in the spring till late in the next fall. That James Cox Senior who has applied for a pension served with him during the said period say something like six months. That during that time they did military duty together and did not attend to farming or any other peaceful occupation. This affiant does not recollect the year that this service was rendered but knows that it was after the commencement of the Revolutionary War and during its continuance –

and further this affiant saith not

And also appeared before me a Justice aforesaid on the same day Isaiah Austin and made oath – That he turned out a volunteer under Capt. John Cox for 9 months. That James Cox Senior the son of said Capt. John Cox, who has applied for a pension, served with him. They were stationed at a Fort on New River at the mouth of Peach Bottom Creek from March until late in the fall ensuing. The above affiant Burwell Spence served at that same Fort during the same time. They rendered military service together during said time and did not attend to farming or any other peaceful occupation. This affiant does not recollect in what year the above service was rendered, but knows that it was after the commencement and during the continuance of the Revolutionary War, and that it was rendered against the Indians. This affiant was afterwards in service in company with said James Cox under his Father Capt. John Cox against the Tories frequently at different times during a year or two – and further this affiant saith not.

I do certify that the said above named Jonathan Thomas to be a man of truth and under a good character Given under my hand and seal this 12th day September 1836.

I Henry Hardin aged Seventy-one years maketh oath that I was acquainted with James Cox Senior of Grayson County Virginia – (who I understand has made application for a pension) during the Revolutionary War – That this affiant knows that the said James Cox served several months – the precise number not known to this affiant as a volunteer against the Indians and Tories that he also took the place of Jonathan Thomas and served in the Army of the Revolution in the place of said Jonathan Thomas – as a drafted militia man – That the officers under whom the said James Cox served were Col. Cleveland (as this affiant believes) and Capt. William Nall – That the said James Cox served altogether in the service of the United States – 2 years as this affiant verily believes. John Cox and also under Capt. Nall and during his service he brought in one wounded prisoner and the said James Cox was taken a prisoner by the Tories and he made his escape from them and joined the Whigs again and continued with them until the end of the war this sworn to and subscribed to before us the day and date above written


Be it known that on the 18th day of January 1838 before us John D Watson and Peter Earnest two of the acting Justices of the peace in and for the County of Ashe aforesaid personally appeared Jessie Ray Senr. [?]⁶ a citizen of said County aged seventy-seven years and made oath in due form of law that he is personally acquainted with James Cox Senior (who this affiant understands has applied or will apply for a pension) – the said James Cox Senior being a resident of Grayson County Virginia – that he knew the said James Cox during the Revolutionary War – that this affiant while himself serving in the Army of the United States saw the said James Cox in the service of the United States under Capt. John Cox and Major William Love and Col. Walter Crockett of the Virginia militia (as this affiant believes they were) – That he cannot state the length of time that the said James Cox served as a volunteer – but knows well that he did serve as such – and saw the said James Cox command – and heard him state at the time that he had been taken prisoner by the Tories and had escaped from them –

He further swears that it has been always currently reported and believed in the neighborhood in which said James Cox resides that he was a Revolutionary Soldier.

Sworn to and subscribed January 18th 1838 before us.

He further swears that day (the North Carolina Army) took a prisoner of the enemy and gave them up to the said Capt. Cox – who had him tried and home by the Virginia Army.

She recites in her application almost word for word the services of her husband as set forth in his original declaration. She signed her name with a mark.]

State of North Carolina, County of Ashe

On this day of April 1859 personally appeared Joshua Cox aged ninety seven years a resident of the County at State aforesaid who being duly sworn; deposeth and says that he is well acquainted with one James Cox, a private in Colonel John Cox's Company Commanded by Colonel Cleveland, in the revolutionary war, that he personally new [sic, knew] the said James Cox while in the service of said war frequent saw him while on duty and know him to have served at least two years in that Military Service. That the said James Cox was taken prisoner while in the service by the Tories and was rescued by a portion of the Regiment Commanded by Colonel Cleveland he also declares that he was in an engagement at a place known as McKinney's Rocks with a company of Tories, in which the Whigs were victorious in said engagement, there were several noted Tories killed and taken prisoner, to wit Captains McKinney, Craig, Goss, Green and various others whose names deponent does not now recollect, deponent further states that he is well acquainted with Sally Cox, widow of the said James Cox, this the said Sally Cox is still a widow and has so remained since the death of her husband James Cox, which death occurred on the 17th day of April 1841, in the County of Grayson & State of Virginia – that deponent states he resides within 17 miles of the Residence of the said James Cox, now his widow, and he resided within that distance ever since the close of the said revolutionary war, declarant further states he has no interest whatever in making this affidavit, and no interest or claim in the benefits to be derived therefrom.

Whereas this day personally appeared Joshua Cox Sr. aged Eighty Seven years old before Solomon B. Jones one of the Sitting Justices of the peace for the said County aforesaid and makes oath as a witness for Sally Cox Widow of James Cox deceased I do hereby certify upon oath that I have perfect knowledge that James Cox served as much as six months in a Military Capacity in the War of the Revolution and in all his service as much as two years – he served under Captain John Cox and also under Colonel Cleveland in North Carolina and Virginia and that he was in the battle at Machinnia Rocks [McKinney's Rocks?] where Machinnia was taken prisoner hung there was some were killed and wounded and the balance absconded and James Cox deceased was taken prisoners by the Tories then Colonel Cleveland with his Company followed after the Tories and rescued James Cox from them at the big glades and also that James Cox was in Company when they went to drive the Indians back at the Long Island of Holston [River] and that said James Cox died on the 17th day of April 1841.
