Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]


of Charles Crawley, Elizabeth Glen, wife of John Glen and of the said John Glen in right of his said wife, and Mary Smith, widow of Samuel W Smith the deceased, made to obtain from Government the arrears of Pension due to their mother Mrs. Hanna Crawley at the time of her deceased by virtue of the Several Acts of Congress as the widow of Captain Charles Crawley their father – for his Revolutionary Services –

Sheweth that they the said Charles Crawley – Eleanor Glen and Mary Smith are the only children of Captain Charles Crawley of the revolution and Hanna Crawley, the said Captain Crawley was never married to any other wife but his said widow and they never had any other children but your Petitioners except an infant who died while two years of age. That their said Father intermarried with his said widow in the State of Pennsylvania; on the 6th day of July A.D. 1780. That he entered into the service at & during the revolutionary war as Captain in the Navy of South Carolina and faithfully and steadfastly served therein and more particularly during the period from the year 1779 to the year 1783 – as will appear by an Indented Certificate from the State of South Carolina a true copy whereof is annexed – Your Petitioner's further humbly represent she suffered in company with his widow the difficulties and perilous incident to the revolutionary warfare they further show that the said Captain Crawley departed this life in the summer in the year of our Lord 1803 and that his said widow never intermarried after his deceased and that she departed this life on the 9th day of June in the year of our Lord 1836. And your Petitioners further show that the Commission held by the said Captain Crawley signed by John Rutledge as Governor of South Carolina was in the possession of your Petitioner Charles Crawley, and destroyed while the schooner Carolina was blown up on the 27th of December 1814 he then being an officer of the said vessel. Your Petitioners Humbly Pray that their said base [?] Together with the accompanying Proofs may receive the awe [?] and favorable consideration of the Department – and that relief and recompense to which they are entitled in the premises be granted: -.

Personally came before me Charles E. Crowley [sic] – who being sworn in due form of law maketh oath that he has always understood from conversations with his mother Mrs. Hannah Crowley [sic] that his father was engaged in the naval Service of South Carolina during the Revolutionary war that he was in action before and at the Siege of Charleston, and naval attacks upon the enemy that he did command a ship called the *Marquis of Brittany* he further saith that such was traditional information of the family and his Commission signed by John Rutledge as Captain in the Navy of South Carolina was kept by the family & was afterwards put in possession of Deponent, and was destroyed on 27th of December 1814 by the blowing up by the British at New Orleans of the Schooner *Carolina* in which the Deponent was the 2nd Lieutenant. He further saith that the only children of said Father & Mother were Mrs. Eleanor Glen, Mrs. Mary G Smith and himself, all of whom are now living in Charleston the other child being an infant who died when two years old, and that his said parents were never married, but in their marriage to each other, and he further deposeth that the annexed marriage Certificate is there true & genuine Certificate of marriage and as such has been carefully kept in the family since the earliest recollection of this Deponent.

South Carolina

Pursuant to an act of the General Assembly passed the 16th of March 1783, we the Commissioners of the Treasury have this day delivered to Captain Charles Crowley this our Indented Certificate for the sum of four hundred and forty-four pounds seventeen shillings and one penny half penny sterling for pay due him as Captain in the Navy of this State in 1780, 1781, 1782 & 1783 per account passed by the Commissioners of Accounts. The said Charles Crowley his Executors, Administrators or assigns will be entitled to receive from this office the sum of thirty-one pounds, two shillings & nine pence on demand for one-year interest on the principal

sum of four hundred and forty-four pounds seventeen shillings and one penny half penny, and the like interest annually. The said Charles Crowley his Executors, Administrators or a science will be entitled also to receive and shall be paid if demanded, the Principal Sum of four hundred forty-four pounds seventeen shillings and one penny half penny on the 16th of August 1787. And the said Charles Crowley his Executors Administrators or assigns, may make any purchases at any public Sales of Confiscated Property (except such as shall be ordered by the Legislature for special purposes) and this Indent shall be received in payment.

For the true performance of the several payments in manner above mentioned, the Public Treasury is made to libel and the faith of the State pledged by the Act aforesaid.

Given under our hands at the Treasury Office in Charleston the 16th day of August 1785.

Personally appeared before me John Cart Senior¹ a witness now in the 80th year of his age – who being sworn in due form of law saith that he was well acquainted with Captain Charles Crowley of the Revolution – and he knew him as an naval officer in the service of the State of South Carolina during the revolutionary war and the Deponent [indecipherable word] particularly remembers him as commanding a Galley then employed in defense of Charleston and thinks that it was at the time of the invasion by Prevost – at that time he was younger than Captain Crowley he afterwards knew him he was in the Mercantile business in Charleston after the revolution and conducted business in the firm of Cross & Crowley and it was always well known and understood that he had been in the naval service of the State in the revolution. He also well knew that he

married and had a family in Charleston and that he left his widow in Charleston after his death and that Mrs. Crowley resided and died in Charleston.
