The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Missouri County of Lafayette SS

On this Eighth day of August in the year 1832 personally appeared in open Court before the Justices of the County Court of Lafayette County in the State of Missouri James Demasters a resident of Lexington Township in the County of Lafayette and State of Missouri aged sixty-nine years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7, 1832. That he enlisted in the Army of the United States in the year 1779 under Lieutenant Jordan and served in the third New Virginia Regiment of the Virginia line under the following named officers, Captain Thomas Buckner, Major Lewis, Colonel William Heath, attached to General Lincoln's [Benjamin Lincoln's] Brigade he left the service in the year 178\_ [last digit obliterated] after having served two years and one month at the time he entered the service he was a resident of Amherst County in the State of Virginia. He was in the battle of Charleston in South Carolina he thinks in the year 1780 in which he was taken prisoner [Charleston South Carolina fell to the British on May 12, 1780]. He thinks that he marched from Amherst County where he first enlisted to Fredericksburg thence to Petersburg thence to Charleston South Carolina and was there taken prisoner in which situation he remained until April 1781 when he made his escape and joined General Marion [Francis Marion] in the South with whom he fought at Fort Motte [May 7, 1781]<sup>2</sup> and thence to Friday's Fort [Fort Granby, May 14-15, 1781]<sup>3</sup> on the Congaree River after we had taken the forte General Greene [Nathaniel Greene] arrived on the same day and I went to him and made my situation known and was by him discharged from any further service and again returned to Amherst County Virginia.

He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the pension list or roll of any agency in any State.

she married James Demasters in 1785 (her oldest son now being 55 years of age); that her husband died March 10, 1836; at the time of his death he was a pensioner of the United States for his services in the Army. She signed her application with her mark.]

[p 10: on January 24 1852 in Ray County Missouri, Foster Demasters filed a claim in which he states he is a lawful son and child of Mary Demasters and James Demasters, both deceased; that he is 59 years of age; that his father died in 1836 and his mother died in 1840, he thinks and believes.

Forter Demostration

[Veteran was pension at the rate of \$80 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 2 years in the Virginia Continental line.]
