George Oldham and that he was in the battle of Gates's defeat [Battle of Camden SC, 16 Aug 1780]. Given under my hand this 8th day of December AD. 1829 John hisXmark Dell

South Carolina } On this 16th day of May A.D. 1853 personally appeared before the Judge Greenville District } of the Ordinary's Court of the State of South Carolina, Greenville District, Evaline Dill, a resident of Greenville District, and state aforesaid, aged Sixty years, who first being duly sworn according to Law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress, passed on the 3^d February 1853 granting pensions to widows of persons who served during the Revolutionary war: that she is the widow of Runnells Dill who was a Private in the Revolutionary war – he volunteered in virginia or north Carolina for six months, under Capt. Oldam, he was at the Battle of Gates defeat, and drew a Pension in his life time from the State of South Carolina. The Tax Collector of Greenville District always paid him his Pension dues. She further states and declares, that she was married to the said Runnells Dill on the 6th day of July A.D. 1830. that her said husband died on the 27th day of October A.D. 1844. that she was not married to him prior to second of January A.D. 1800 but at the time above stated.

Pension Application of Runnels Dill R2953

On this 5th day of May A.D. one thousand Eight hundred and fifty five Personally appeared before me a Notary Public and Magistrate Ex. Off. within and for the District & State afore said Evaline Dill aged 60 years a resident of Greenville District in the State of South Carolina who being duly sworn according to law declares that she is the widow of Runnels Dill, Deceased, who was a private in the company commanded by Captain George Oldham in the Regiment of volunteers commanded by Col. [blank] in the ware of the Revolution Declared on the 4th day of July AD 1776 and that her said husband volunteered in Caswell County in the State of North Carolina and that he served in South Carolina. he volenteered For the term of Six months & continued in actual service in said war for the term of Three months and was honorably discharged at [blank] She declares that her said husband has recived a pension from the State of South Carolina for many years previous to his death She further states that she was married to the said Runnels Dill on the 26th day of July AD 1832 by one David Jackson and that her name before her said marriage was Evaline Hooper & that her said husband died at Greenville in the State of South Carolina on the 27th day of October A.D. 1844 and that she is now a widow.

She makes this declaration for the purpose of obtaining the bounty land to which she may be entitled under the act approved March 3rd 1855 she states that she has no record of her marriage.

NOTES:

A letter to the Pension Commissioner dated 22 Nov 1853 states that besides John Dill, Runnells Dill "also had another brother that done service."

A letter dated 17 Jan 1854 states that an 1844 tax receipt signed by C. P. Dill, Tax Collector, was

enclosed as proof that Evaline Dill was the widow of Runnels Dill.

A letter by John Odam dated 26 Jan 1860 reads in part, "David Jackson Esqr told me he went with Dill to capt Oldham himself capt Oldham went to Esqr Henderson with them stayed all night together, in Anderson Dist then Capt Oldham gave Dill a certificate and his Affidavid stating that he commanded Dill in the Revolutionary War and a volunteer from caswell county North Car, and upon that Certificate the state of South Carolina gave him a pension of Sixty Dollars per year this was in the year 1831."

Evaline Dill's application for bounty land was supported by a deposition by James Odam and George W. Dill. David Jackson stated that he married Runnells Dill and Evaline Hooper on the 6th day of July 1830. On 3 Aug 1859 Evaline Dill stated that she had lived in Greenville District for about 45 years before her husband's death, and he had lived in Rockingham County NC before then.

Evaline Dill never received a pension, but by error an application was made on 17 Nov 1866 for restoration of a pension that was supposedly suspended during the Civil War, during which time she had subsisted "from the support and aid of her kindred." A reply from the Pension Office states in part, "The claim of Caroline Dill for a pension as widow of Wm. Dill a soldier War 1812 cannot be considered, unless it is clearly shown that he died of wounds rec'd or disease contract in service or line of duty."

A document signed by Evaline Dill on 13 April 1869 was certified by her son, Theron E. Dill. On 20 Sep 1873 George W. Dill certified the loyalty of Evaline Dill. Evaline Dill was said to still be living on 4 April 1881.

[Note: there are numerous documents in this file all relating to administrative matters concerning the state pension paid by South Carolina to Runnels Dill for his service in the Revolutionary war. None of the documents contain any descriptions of the services he rendered during the revolution. It appears that he received a pension of \$60 per annum commencing in 1831 until his death on October 27, 1844. His estate was administered by James Odom. In addition the file contains petitions by the veteran's widow (Eveline Dill) attempting to have her husband's pension extended to her benefit. Her petition was denied. All the documents in the file signed by the veteran or his widow were signed with their respective marks.]
