Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undecipherad' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Kentucky, Clinton County

On this the 17th day of March 1854 personally appeared before me Thomas Harber a Justice of the Peace in and for the County & State aforesaid John Duvall aged 76 years a resident Citizen of the County & State aforesaid and being a man of Good Character & after being duly sworn for that purpose on his oath makes the following affidavit or Declaration To wit: that he is the son of Lewis Duvall, Deceased who lived in Laurens district in the State of South Carolina & from there went into service during the Revolutionary was as Captain of a Company & that his said Father, died 46 years ago in the State of Illinois in the [2 or more indecipherable words]¹, that he left a widow Elizabeth Duvall, who remained a widow until about August last was a year ago, that affiant states that as he has learned from his father & mother that his father served through the Greater part of the Revolutionary war & may have engaged to serve that length of Time & as he believes served to the end thereof but cannot be positive. Affiant states that his said father & mother had several Children some of whom are alive & some dead. That he lived far from his mother & was unable to render her any assistance in the prosecution of her Claim during her life that his father served as before stated according [to] information & in such manner as to entitle his widow to a pension he prays an examination of the Rolls for the service & in the event of the service or any Trace [?] being found there for such instructions as the rules require which will be alluded to as to the death of the widow &c., he declarant prays that an answer in the Case the forwarded to Wm. J. Dabney of Albany (his attorney). There was a man by the name of Gideon [?] & there was a man by the name of Raney who was a captain from the same place and often spoke of his & Duvall's service.
