Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Randolph County

On this second day of May A.D. 1854 before the Court of Pleas & Quarter Sessions for said County and State aforesaid May Term 1854 held at Ashboro [Asheboro] personally appeared Garrett Lane a resident of Randolph County aforesaid, who being first duly sworn according to law doth on his oath make the following declaration to obtain the benefits of the acts of Congress passed on the 7th day of June 1832 granting pensions to officers & soldiers who served in the Revolutionary War. That he is the administrator of Abraham Elliott who was a soldier in said War and served about 12 months as the proof herewith presented will show, and that said Abraham Elliott died on or about the 17th day of April A.D. 1843 and that he left no widow, him surviving but that he left four children, Namely: Joseph, Jeremiah, Mary Allred, & Elizabeth Gray all of whom have since died except Elizabeth Gray, who is still living.

[Howgal Julian and Lorenzo Wood testify as to Elliott's death and the children surviving him.]

[Eli Allred, 76, of Randolph County testified on July 23, 1846, that he "was well acquainted with Abraham Elliott and that he saw him in the service of the Revolution War and that he Elliott was at his father's different times while in the service with Captain Hines [John Hinds] under Colonel Litteral [John Luttrell] as to the time he (Elliott) served he cannot recollect precise but he the said Eli Allred recollects it was six months or more and that said Elliot was married to a woman named Ruth Fields and the said Eli Allred recollects his brother William Allred was in service with Abraham Elliott in a little skirmish near Salisbury at one time and that he & Elliott came home and went to the Barax [barracks—Luttrell's Barracks.]

[John Allred, 83, of Randolph County testified on July 22, 1846 "that he was well acquainted with Abraham Elliott his neighbor and he frequently heard him say that he was in the Revolution under Colonel Luttrell in a scrimmage near Salisbury and at another time went a trip to South Carolina and frequently heard him speak of the narrow escapes and other different circumstances that occurred & saith that he has frequently heard others speak of his being in the service & he has every reason to believe it to be so for the always appeared to be a man of truth. But how long

he served he is unable to say."]

[Joseph Elliott, 70, of Randolph County testified on July 23, 1846, that "he was well acquainted with Abraham Elliott, his Uncle, and that he was in the service of the Revolutionary War in one trip towards Salisbury and another towards the South under Colonel Luttrell and A. Elliott's wife's name was Ruth but how long he served he is unable to say."]
