Pension application of Samuel Finley R3556 Transcribed by Will Graves f16NC 12/26/08 rev'd 2/12/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Kentucky Butler County Sct.

On this 12th day of September 1826 personally appeared in open Court being a Court of record for said County Samuel Finley resident in said County aged 65 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the act of Congress of the 18th March 1818 and 1st May 1820 & March 1823, that the said Finley enlisted for the term of during the War about the year 1776 in the State of North Carolina in the Company commanded by Captain Steward in the Regiment commanded by Colonel Armstrong in the line of the State of North Carolina the Continental establishment & was then transferred to Colonel Williams of the Virginia line -- That he continued to serve in said corps till the end of the War when he was discharged from said service at 96 [Ninety Six] in the State of South Carolina -- he applied for a pension some years since and his discharge & declaration were sent to the Honorable David Walker a member of Congress from this district, said Walker died & the papers have not been heard of by me since -- he was in the Battles of Camden [either the Battle of Camden, August 15-16 1780 or, more likely, the Battle of Hobkirk Hill, April 25, 1781] Eutaw Springs [September 8, 1781] Guilford [March 15, 1781] & many skirmishes

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed -- my property consist of one cattle one calf & a 2-year-old heifer. I have made no contracts or anything except a few of the necessities of life since the 18th March 1818. I have a wife & five young children from age & infirmity I am unable to do much labor.

For the purpose of obtaining the benefits of an act entitled an act for the relief of certain surviving officers & soldiers of the Army of the Revolution approved on the 15th of May 1828 I Samuel Finley of the State & County aforesaid do hereby declare that I enlisted about 1778 or 1779 as well as I can now recollect in the Continental line of the Army of the Revolution for & during the War & continued in its service until its termination at which period I was a private in Captain Nelson's company in the Regiment commanded by Colonel Armstrong of the line in the State of North Carolina -- And I also declare that I did not received a certificate for the reward of \$80 to which I was entitled under a resolve passed the 15th May 1778 And I further declare that I never was on the pension list of the United States -- Subscribed & sworn to before me the 15th day of September 1829.

He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain \_\_ 's Company, in the Col. Armstrong's regiment of the North Carolina line; and that he never did received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing
