Pension application of William Fowler R3709 Lucy Fowler f19NC Transcribed by Will Graves 1/5/09 rev'd 6/14/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of North Carolina Granville County

On this fifth day of Marched 1845 personally appeared before the subscriber an acting Justice of the Court of Pleas and Quarter Sessions of the County and State aforesaid Mrs. Lucey Fowler, a resident of the said County aged Eighty Three years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the acts of Congress passed July 7th, 1838 -- also an act passed 3rd March 1843 -- also an act passed the 17th June 1844 -- entitled an act to continue the pensions of certain Widows -- That she is the widow of William Fowler who was a private soldier in the war of the Revolution and as well as she can recollect served in Militia under what officers he served she is unable to say but thinks Asy High [Alsey High] was Captain & Philemon Hawkins was Colonel [Lt. Col.] a part of the time as regards the length of time her said husband served she is unable to say but has often heard him say that he was in the service during the most of [the] war. She further declares that she married the said William Fowler on the second day of January in the year 1786 and that her husband the aforesaid William Fowler died on the second day of January 1833, that she was not married to him prior to his leaving the service but the marriage took place previous to the 1st day of January 1794 and at the time above stated -- she further declares that she has no documentary evidence in support of her claim and that in consequence of bodily affliction she is unable to appear in open Court to this declaration

[p 6: Copy of the marriage bond dated January 2, 1786 given by William Fowler and William Farrow conditioned upon the marriage of William Fowler and Lucy Hudspeth.]

[p 7: Affidavit given in Granville County North Carolina on March 6, 1845 by William Johnson, 68, in which he states he was acquainted with the veteran for about 40 years; that the affiant heard the veteran say he served several tours in the Revolutionary War part of which was in Virginia; the affiant thinks he heard the veteran say he served under General Hawkins a part of his time; affiant says that he and the veteran married sisters, the veteran having married Lucy Hidgepeth. The affiant signed his affidavit with his mark.]

[p 9: On March 7, 1846, in Granville County, NC, George Pettyford [also spelled Pettiford], 90,

a free man of color, gave an affidavit as to having had frequent conversations with William Fowler about his services in the Revolution. He signed his affidavit with his mark.]

Be it remembered that on the 3 day of May 1845 before the Subscriber an acting Justice of the Peace in and for said County personally appeared John Fowler who having been duly sworn certifies and says that he has been well acquainted all his life with Mrs. Lucy Fowler widow of William Fowler late of Granville County now applying for a pension, that he also well knew Mr. Fowler and always understood that he was a soldier of the Revolutionary War having frequently had conversation with him upon the subject, that he told me that he served under Hawkins that I went with said William Fowler to see Hawkins upon the subject but on getting there we found Mr. Hawkins so unwell that we were unable to do anything and Mr. Hawkins died in a very short time and the said Fowler became deranged and was unable to attend to any business and remained so up to his death, it never has been questioned but that the said Fowler was a soldier in the Revolutionary War and served a Considerable time I heard him say that he was out at one time twelve months.

This day personally appeared in open Court, John Fowler, who being first duly sworn according to law deposeth, that William Fowler, late of said County said he had served two tours in the war of the revolution & that he so stated in a former declaration taken for William Lion [sic William Lyon]: & that each tour was six months: he further states that he is about fifty-five years old -
