[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Mississippi Yalobusha County

On this 27th day of July [1839] personally appeared Solomon Fudge a resident of the State and County aforesaid aged seventy-three or four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832. That he enlisted in the Army of the United States in the year of A.D. 1781 with Capt. William Covington and Major Samuel Crafton. His commander in chief was General Williamson [Andrew Williamson]<sup>1</sup>. His first enlistment was in Edgefield District South Carolina. They were then watching the British who were forted at Augusta in Georgia. His Capt. having resigned he quit the Army under Williamson and then volunteered under Capt. John Carter and Lieut. Thomas Carter in the light horse company his Col.'s name was Pervis [John Purvis]. Being minute men they always held themselves in readiness sometimes they were out for 2 or 3 months and sometimes longer. His whole campaign was about 2 years during the close of the war. He recollects of being in no regular engagements. And the country through which he passed marched was South Carolina.

He hereby relinquishes every claim whatever And he declares that his name is not on the pension Roll of any agency in any State.

State of Mississippi Tallahatchie County: SS

On this 13<sup>th</sup> day of January A.D. 1840 personally appeared before me Hudson Allen Judge of the Court of Probate in and for said County and State aforesaid Solomon Fudge aged Seventy-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7<sup>th</sup> 1832. That he volunteered in the Army of the United States in the year 1781 with Captain William Covington and Major Samuel Crafton that his Commander in Chief was General Williamson. He first volunteered and served in Edgefield District South Carolina. The British were at this time stationed at Augusta Georgia he says after leaving General Williamson his Captain resigned and he then volunteered again under Captain John Carter his Brother Thomas Carter being first Lieutenant this last service was in a light horse Company his Colonel's

name was Pervis they were Minute men some time they were out for 3 or 4 months at a time they always held themselves in readiness to march at a minutes Warning he was in the service of the United States about two years in all being the last two years of the War. Was in no regular engagement and the only Country through which he traveled [was] South Carolina. He was in the service at the time [ink blot obliterates several words] the British then being at Augusta. Their Commander was Grayson's [sic, James Grierson]. He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares his name is not on the Pension Roll of any Agency in any State. Sworn to and subscribed the day and year aforesaid S/Solomon Fudge, X his mark

[p 20: Power of attorney dated January 7, 1853 given by Elizabeth Fudge in Tallahatchie County Mississippi as the widow of Solomon Fudge. She signed this document with her mark.]

[Facts in file: Veteran died January 7, 1853 survived by his widow Elizabeth Fudge who, in 1853 was living in Tallahatchie County Mississippi. The file contains no other family data.]
