Calaway County [Callaway County] SS[?] On this 16 day of July one thousand eight hundred and forty four before the Subscriber one of the judges of the County Court in and for the County and State aforesaid the same being as Court of Record and so declared by the Law creating it personally appeared Mary Glover a resident of said County aged Eighty two years who being first duly sworn according to Law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the act of Congress passed July the 7th 1838 entitled an act granting half pay any pensions to certain widows that she is the widow of Chesly Glover who was a private in the army of the Revolution that her said husband was not a pensioner that he served six towers [sic, tours] of six months each or three months each in the militia as she

supposes of Buckingham County in Virginia She does not remember who his officers were as she was [? probably "married"] to him after the war only she remembers that her said husband was in the Battle of Guilford Court House [March 15, 1871] and in the tour of duty in which this happened he was under Captain Peter Guerant[?] That her said husband was also at the Battle of York at the taking of Lord Cornwallis [October 19, 1781] She further Declares that she was married to the said Chesly Glover in Buckingham County in Virginia on the 29th day of January one thousand seven hundred and eighty five but does not know whether it was by License or publication ^(but believes it was by license) and that the annexed family record was written more than fifty years ago by Chesley Glover and has been in possession of the family all of the time since it was in her husband's keeping during his life time She further declares that her said husband Chesly Glover died on the 17th day of February one thousand eight hundred and twenty nine and that she has not intermarried but remains the widow of Chesley Glover deceased.
