[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Alabama, County of Autauga SS

On this the Eleventh day of October in the year of our Lord 1852 personally appeared in open Court now sitting before the undersigned Judge of the Probate Court in & for said County which is a Court of Record, Lewis Golsan, a resident, of said County and State aged Seventy years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the Act of Congress passed July 4, 1836: That he is the son and heir at law of Elizabeth Golsan deceased late of Autauga County State of Alabama who was the widow of Lewis Golsan deceased formerly of the District of Orangeburg in the State of South Carolina & who was an officer in the war of the revolution and who as this Deponent have been informed & verily believes, entered the service in the American Army under the following named Officers and served as herein stated: that during the said war said Lewis Golsan who was then Lewis Golsan Junior lived as aforesaid in South Carolina & in the same neighborhood with Colonel William Thomson & Lieutenant Colonel William Russell Thomson and that it is likely his first service was rendered under the former who was Colonel of the 3rd South Carolina of Rangers. In what capacity this declarant is unable to say. That subsequently and approaching the close of the war said Lewis Golsan Junior served in the capacity of Sergeant of the company of militia commanded by Captain Jacob Rumph also of his neighborhood & under Lieutenant Colonel William Russell Thomson aforesaid in the Brigade commanded by General William Henderson: That this service was for a period of six months and was in the infantry. That as to the countries through which the said Brigade passed or the battles in which said father said Lewis Golsan Junior was engaged not having charged his memory therewith when detailed in his presence by his parents cannot now specifically speak: That in the latter portion of said service was as a volunteer as this Declarant believes & at all events was in the Militia Service: as to the service is said father may have performed in the Continental Line this deponent respectfully solicits an examination of the Rolls of said 3rd South Carolina in confirmation thereof. That before the last period of said father's service, viz., that as Sergeant in Captain Jacob Rumph's Company, Henderson's Brigade, to which this Declarant speaks with certainty said father married his said mother in said section of said State about the year 1779 but as to the particular date deponent is unable to speak the family Record having since been partially destroyed so that the precise date of said marriage cannot now be given with certainty: That his brother John Golsan deceased if now living would be about 72 years of age he being the first issue of said parents. That after said war was closed said father lived & died in said District

of Orangeburg in the State of South Carolina, his death taken place on the 20th day of July A.D. 1822. And that afterwards his said wife said Elizabeth Golsan remained a widow until her death which took place in Autauga County State of Alabama on the 8th day of November 1846: That in support of the above allegations the deponent respectfully refers to the testimony herewith accompanying & to be adduced. That said mother never made application for her pension as such widow not having been aware of her thereto in her lifetime: That this Declarant has frequently heard his said parents speak of the hardships & separation they endured during said war and that his said mother was once kept by the enemy as a prisoner: All of which will more fully appear by reference to the proof hereto annexed & hereafter to be submitted.




