Pension application of William Hockaday (Hackaday) R4405 Anna fn35NC Transcribed by Will Graves 5/6/11

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this 5th May 1856 personally appeared before the Court of Pleas and Quarter Sessions of Granville County State of North Carolina James Hockaday aged 56 years who being first sworn in open court according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 7th 1838 entitled an act granting half pay and pensions to certain widows that he is the son of the widow Anney Hockaday who was the widow of William Hockaday his father deceased who was drafted a private in Halifax County State of North Carolina in the company commanded by Captain William Hall in Halifax County North Carolina in the revolutionary war of the Colonel he has no recollection he has no record in his possession nor knowledge of the date his said father was drafted and entered the Army or what services he rendered he further declares he often heard his said father relate the particulars of the Guilford battle in which battle he was engaged in [on] March 15th 1781 he refers to documentary evidence as proof of service he further declares that his said father married his said mother in Halifax County North Carolina about the year of 1790 and that his said Father died in Granville County North Carolina in the year 1828 leaving his widow surviving him whose maiden name was Anney Powell who never married after his said Father died he further declares that his said mother died in the year 1851 on this 16th day of May by reference to the Bill of sale recorded in the Clerk's office in Granville County North Carolina leaving at her death 4 children who are now living to it Elizabeth Cannaday Lucy Adams Nancy Terrell and James Hockaday he makes this declaration in order to obtain the arrears due his deceased mother under the Act of Congress 7th of July 1838 he further declares that he surrenders a leaf of an old English prayer book the only leaf preserved containing the age of his Father and mother and eldest brother and sister he further declares that this is the first declaration for the services of his deceased father. 
