[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia Wilkes County: SS

On this fifth day of June 1838 personally appeared in open Court before the Inferior Court of said County sitting for Ordinary purposes Robert Hackney a resident of said County of Wilkes and State of Georgia aged seventy-eight years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he enlisted as a volunteer in the third Virginia Regiment in the first part of June 1776 at the town of Port Royal in Caroline County in Virginia. The company (in which he served as private until 1777 when he was promoted to the rank of Sergeant, in which office he continued until discharged) was commanded by Captain Samuel Hawes who died in 1777 and then Captain Thomas Naylor took the command. The name of the Colonel was as he says Mathews (or Mathis) & the name of the General was Thomas Nelson –

That he was discharged from the service in the year 1781 but does not recollect the precise day on which he was discharged but it was soon after the siege of Yorktown & he thinks it was about the 27th of October.

That he was at a battle at old Jamestown on James River serving under the command of Captain Thomas Naylor and General Lafayette.

That he was at a skirmish at Dabney's Mill on a retreat from Williamsburg in which retreat he passed through Spotsylvania County near the town of Fredericksburg through Orange into Culpeper County.

That he was at the siege of Yorktown and was one of those who guarded prisoners taken at that place thence to the Raccoon Ford on the Rapidan River.

That he has no documentary evidence wherewith to enforce his claim which evidence having been left in Virginia when he removed to Georgia and he knows of no person who can testify to his service.

He hereby relinquishes every claim to a pension or annuity except the present and declares that his name is not on the pension Roll of any agency in any State – Sworn to and Subscribed the day and year aforesaid.
