[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

#### District of North Carolina: SS

On this Thirteenth day of July 1818, before me the subscriber, one of the Judges of the United States for the said District, personally appeared James Hall, aged Sixty-two years, resident in Johnston County in the said district, who being by me first duly sworn, according to law, doth on his oath, make the following declaration in order to obtain the provision made by the late act of Congress entitled, "An Act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war:" That sometime during the revolutionary war, and in that year in which the Sun was totally eclipsed, in the County of Wake & State of North Carolina, he the said James Hall enlisted in the company commanded by Captain Alsa High [Alsey High], of the tenth Regiment of the North Carolina line, on the Continental establishment, in the war aforesaid, for the term of nine months; that he continued to serve in the said Corps, but part of the time under Captains Ramsay & Quinn [Michael Quinn], until the end of his said enlistment & twenty days over, when he was discharged from service in Charleston in the State of South Carolina; that afterwards, he became the substitute of William Ross of Franklin County, State of North Carolina, and as such entered the service at Halifax in the State last aforesaid, & served in the said war against the common enemy, for the term of twelve months, on the Continental establishment, in the North Carolina line & Second Regiment in the company commanded first by Captain Evans & then by Captain Yarborough [Edward Yarborough], & at the end of his said the latter service he was discharged at Ashley Hill in South Carolina; that both of his said discharges he lost many years ago; that he was in the battle of Stono<sup>1</sup>; and that he is in reduced circumstances, and stands in need of the assistance of his country for support.

State of North Carolina Wake County: Superior Court Autumn Term 1820. On this 5th day of October 1820 Personally appeared in open Court it being a Court of record James Hall aged sixty-three years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provisions made by the Acts of Congress of the 18th of March 1818 and the 1st May 1820. That he the said James Hall enlisted first for the term of 9 months & served out that time & afterwards enlisted for the term of 12 months. On the day of the \_\_ in the year 1781 in the County of Wake at the old Court house in the State of North Carolina in the company commanded by Captain Edward Yarborough in the Regiment commanded by Colonel Robert Mebane being in the 2nd & 10th Regiments in the line of the State of North Carolina on the Continental establishment that he continued to serve in the said Corps until the month of April 1782 about the 8th day at Bacons Bridge on Ashley River in the State of South Carolina that he was in a severe Battle at Stono, and was marched from that State through the State of North Carolina & continued in the said Service until he was honorably discharged at the place & time aforesaid & that he has no other evidence now in his possession of his said Service except what he has heretofore exhibited.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income nor means of support except what is allowed me as a pension under the act of Congress Congress of the 18th of March 1818 which I have received from the Bank of the United States at Fayetteville Congress of the 18th of March 1818 which I have received from the Bank of the United States at Fayetteville by virtue of my pension Certificate being Congress of the 18th of March 1818 which I have received from the Bank of the United States at Fayetteville by virtue of my pension Certificate being No. 5667 and that he has received 2 pavements their own including all due up to the 11th March last.

Personally appeared in open Court, it being a court of record, James Hall of said County aged 63 – years who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war in the 2nd & 10th Regiments in that Company commanded by Captain Edward Yarborough of the North Carolina line and that his original declaration was made before Judge Potter on the 13th day of July 1818 & has received to pay months as before stated by virtue of his pension Certificate No. 5447 and I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to

provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

That his family are composed of himself aged 63 years his wife Edy Hall aged 50 years, his son Riddick aged 15 years very small & sickly & born a cripple in his feet & Green aged 8 years small but healthy – These four comprise all his family, that his occupation is a farmer upon rented land having to pay one quarter of all he makes and being himself very infirm he is unable to maintain himself & family and that he has no person to contribute to his assistance or any other means of support.

This day Major Lodwick Alford personally appeared before me Matthew Strickland one of the Justices of the peace in the County of Wake and State of North Carolina and maketh oath that James Hall Senior did enlist out of his company in the 9 months Service in the Army of the United States on the Continental establishment in the revolutionary war and he does sincerely believe that said Hall did faithfully served the term of 9 months and there was never any complaint against said Hall on the account. Also he hired said Hall to serve a 12 months Tower [tour] for William Ross an outlier and do sincerely believe said Hall did faithfully serve the time out as he never heard anything to the contrary, And I do verily believe that said Hall does stand in need of the assistance of his country having been personally acquainted with him for many years and he has always appeared to be under complaints;
