Pension application of Joel Hampton R4547 Hannah Hampton f60NC Transcribed by Will Graves 4/7/11: rev'd 2/18/18

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky County of Logan Sct.

Personally appeared before the undersigned an acting Justice of the Peace in and for said County Hannah Hampton a resident of said County aged 79 years, who being first duly sworn according to law doth, on her oath, make the following Declaration in order to obtain the benefit of the act of Congress passed on the 7th of July 1838 and also all subsequent acts granting pensions to the widows of Revolutionary Soldiers.

That she is the widow of Joel Hampton, who was a soldier in the Revolutionary War, from Wilkes County North Carolina; that from what she has heard her husband say Joel Hampton say touching his service in said War said Hampton entered said service as a private in the North Carolina Militia or State Troops in the Spring of the year 1779 and continued in said Service until the close of the war in the year 1783. She states that during the above time he occasionally returned home but did not remain long until he was gone again. She states that she was living in the same neighborhood where said Hampton lived, when at home, and she recollects distinctly that he was in said Service almost all the time the war continued. She states that owing to the lapse of time and a failing memory, she cannot now recollect the names of his captains &c. She remembers that he was a good part of his time under Colonel Cleveland [Benjamin Cleveland] and also under Colonel Campbell [presumably William Campbell of Virginia] and General Morgan [Daniel Morgan] and that he was at the battles of Stono [June 20, 1779], Hanging Fork [sic, Hanging Rock?, August 6, 1780], Ramsour's Mills [June 20, 1780], Cowpens [January 17, 1781], Kings Mountain [October 7, 1780], on Deep River, and others that she cannot now call the names of.

She further states that the said Joel Hampton received at the time he left said service, several Discharges that she has seen said Discharges frequently but that they have all been destroyed or lost long since. She further states that said Joel Hampton died on the 20th of August 1833 in Logan County Kentucky. She further states that she was married to said Joel Hampton on the 14th day of November 1783 in Wilkes County North Carolina at the house of John Greer [could be Green] and by John Brown, a Justice of the peace about one month after said Hampton had returned home from an expedition against the Indians. She states that she does not know of but two persons now living who were present at her marriage – her sister Pathiah Mitchell of the State of Missouri and Temperance Greer [could be Green] of Kentucky. She states that her maiden name was Hannah Mitchell and that she thinks she was married by license as she remembers hearing the people joking said Hampton that she only cost him one

dollar. She states that she has never married since the death of said Hampton but continues to be and remained his widow. And that she was married to said Hampton prior to the year 1794 to wit on 14th November 1783.



[p 21: On February 27, 1846, in Edmondson County Kentucky, Temperance Greer, 76, gave testimony that she was born in Wilkes County North Carolina; that when she was about 13 years of age she was at the marriage of Hannah Mitchell to Joel Hampton; they were married at the house of the affiant's grandfather John Greer in 1783; John Greer lived at the time about 3 miles

South of the County seat; that Hannah and Joel were married by John Brown, a justice of the peace; that she remembers distinctly that Joel Hampton and her father, John Greer, served together a 3 months tour and that they served together several tours thereafter; that they served under Colonel Cleveland and on the first tour of 3 months they were in the South on Pedee and Charleston and were at a battle called Stono that was about 18 months or 2 years prior to said marriage; that she believes said Joel Hampton and was at 3 other engagements, Ramsour's Mills, Cowpens and Kings Mountain.]

[p 24: On February 27, 1846, in Edmondson County Kentucky, Nancy Greer, 96, gave testimony that she was living in Wilkes County North Carolina at the time of the marriage of Hannah Mitchell to Joel Hampton; she lived in the same neighborhood; that they were married in 1783 in the house of John Greer by a magistrate named John Brown; that they lived together as man and wife and raised a large family of children; that said Hampton was a revolutionary soldier and served with the affiant's husband in the revolutionary war.]

[p 25: On June 26, 1847 in St. Francios County Missouri, Pethiah Mitchell, 77, gave testimony that she is the sister of Anna Hampton; that she was present at their marriage at the house of John Greer in Wilkes County by John Brown on the 14th of November 1783.]

[p 30: On August 20, 1847, in Edmondson County Kentucky, Smith Greer, 61, gave testimony that he married a daughter of Joel and Hannah Hampton; that his wife was the oldest child of Joel & Hannah; if she were still alive she would be 62 years old according to the record of her age in affiant's Bible, she having been born in 1785.



[p 51-53: the widow petitioned the U.S. Congress for a pension pursuant to a petition dated January 29, 1848.]

[Facts in file: the veteran and his wife had the following children who were living as of 1846: James, Joshua, William, Andrew, Sally, Ally and Hannah Hampton. Their oldest daughter, Nancy, was then deceased. Nancy was born February 5, 1785.]

[Facts in file, a note in the file indicates that the widow's petition was denied because she failed to prove the requisite 6 months service.]
