Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Senate & House of Representatives of the State of South Carolina Robert Hanna presents himself to your Honorable body as an old & infirm revolutionary soldier, who is now sixty-six years of age & a large family part of which are young & females and have heretofore reclined upon your petitioner for a support but your petitioner is now so reduced in his circumstances & his infirmity is such that he is unable any longer to support himself & family with his means & labor, therefore prays your Honorable Body to place him on the pension Roll during life. Your Petitioner begs leave to recount to your Honorable body his toilsome duties in the revolutionary war, to wit, he served two tours of duty against the Indians one under Captain Leard [Robert Laird], Colonel Kilgore [Benjamin Kilgore] and the other under Captain Leard & General Pickens [Andrew Pickens] also done duty under Captain William Harris at Edgel's old field & Kittels station, also under Captain Harris at Hayes station, ¹ & many scouting expeditions under General Pickens, and was at the Siege of Ninety Six, ² under Colonel Levi Casey and lost a valuable gilding.

[p 35: of November 10, 1854, Elizabeth Hanna gave testimony in Abbeville District South Carolina that she is the widow of Robert Hanna who resided in Laurens District South Carolina until the year 1837; that he died in March 1837 in Abbeville district South Carolina; that he received a pension from the state of South Carolina for his services in the revolutionary war at the rate of \$65 per annum until his death; that she was married to him in the month of October or November in the year 1799 in Laurens District South Carolina by the Reverend John Kennedy, a preacher of the Presbyterian Church; and that she knows of no public or private record of her marriage.]

[p 36: David Hanna testified on November 10, 1854 that he is the oldest child of Robert and Elizabeth Hanna; that he is now 54 years of age having been born on July 6, 1800 according to a private record kept in his family.]

[Facts in file: the widow's maiden name was Elizabeth Templeton; in 1851 she stated she was 76 years old; her claim for a pension was denied because she failed to establish that her husband served for at least 6 months in the revolutionary war.]
