And the reason that he has not sooner applied is that he has been almost helpless for several years & could not travel to get his writing done by any person who pretended to know anything about it without exhausting & fatiguing himself so much that he could not bear it. And this declarant has no other evidence whereby to establish his claim except his own oath, that he knows of from the great length of time that has intervened from the rendering of the Services until the present time.

To the first interrogatory, he answers I was born in Sussex County Virginia as I was informed by my parents in the year 1758, the month & day I have no means of knowing.

To the Second he answers I have no record of my age.

To the third, he answers I have lived in Hancock, Jasper and Pike counties Georgia & previous thereto I lived in Virginia & North Carolina.

To the fourth he answers I volunteered every time.

To the fifth he answers I can state the names of Major Soward of the Cavalry, Colonel Parker (Major DeCluman, a French officer) [Christian Charles de Klauman], Colonel Meriwether, their Christian names I cannot recollect.

To the sixth he answers I received one written discharge & it was for three months service in the Cavalry Company, but I have long since lost it.

To the 7th, he answers I can named John B Reid and Willis Mangham. [John B Reid and Willis Mangham gave the standard supporting affidavit.]
