Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia To wit

At a Court held for the County of Harrison on the 19 day of June 1818 & 42nd year of the Commonwealth, present John Simmerville, Peter Lynch, Daniel Morris & John Reynolds, Gentlemen Justices Before the Court aforesaid personally appeared David Harrison and being duly sworn according to law doth on his oath make the following declaration in order to obtain the provision of the late act of Congress entitled "an act to provide for certain persons engaged in the land and Naval service of the United States in the revolutionary war," That he the said David Harrison enlisted in the regular Army of the United States in the year __ in the state of Virginia in the company commanded by Captain Stewart of the Regiment commanded by Colonel Wadsworth for the period of one year that he continued to serve in the said Corps or in the service of the United States until the peace when the Army was discharged and he was discharged at Chesterfield in the State of Vermont that he served for the full period of Eleven Months that he was at the battle of Powles Hook [Paulus Hook, August 19, 1779] & that he is in reduced circumstances & needs the assistance of his Country for support and that he has no other evidence now in his power of his said service.
