Pension application of William Harrison R4688 Transcribed by Will Graves f30SC 12/29/10: rev'd 4/15/22

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Alabama, Dale County}

On this 9th Day of November in the year of Christ 1832, Personally appeared before the undersigned Justice of the peace William Harrison a citizen of the County and State aforesaid aged 74 years, who being first duly sworn, according to law, doth, on his oath, make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7, 1832. That he enlisted in the Army of the United States in the year, unknown, with Michael Watson Capt. of the State troops and served in the fourth Regiment of the Line, under the following named Officers: I was under the Command [of] General Pickens, (and have forgotten the name of the Col.) Brannen Commanded as Major. I left the Service, when the association of arms date not recollected. I served three years at the first term of enlistment and after the Expiration of the three years aforesaid I Enlisted again under Capt. Watson for the term of three years longer; and after the Expiration of that time, I again enlisted for three years under the aforesaid Capt. and served about One year when the Association of arms took place. I then was discharged. I resided in Edgefield district South Carolina, and marched from thence, to Savannah River near Augusta. I was in the battle at the Utaw Springs [Eutaw Springs, September 8, 1781], I, generally was out on a Scouting party under my aforesaid Capt. Watson from Augusta to the Congaree River.

He hereby relinquishes every claim whatever to a pension or an annuity, except the present, and he declares that his name is not on the pension roll of any agency of any State.

State of Alabama Dale County: Personally appeared before me, the undersigned Justice of the Peace, William Harrison who, being duly sworn, deposeth and saith, that, by reason of old age, and the consequent loss of memory, he cannot swear positively as to the precise length of his service; but, according to the best of his recollection, he served not less than the periods mentioned below and in the following grades; for seven years I served as a Regular soldier in the Army of the United States, first tower [tour] three years under the command of the officers specified in my Declaration made the ninth day of November A.D. 1832; 3 years at another time and after the expiration of that term I enlisted three years longer and served only one year, and was discharged. This deponent further saith that he got his discharge and all his papers together with his house burnt. This deponent further saith that he is wholly unable to attend a Circuit or County Court by reason of bodily infirmity, and that he knows of no person by whom he can prove his service all have Deceased or moved out of his knowledge. And for such services I claim a pension. This 22nd day of October in the year of Christ 1833.
