Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." State of Indiana Washington County: Washington Circuit Court October Term 1823

Personally appeared in open Court it being the Washington Circuit Court in the Second Judicial Circuit in the State of Indiana which is a Court of Record this 15th day of October 1823 Joshua Hays aged 64 years a resident of the said County of Washington in said State, who did on his Oath state and declare that he enlisted into the service of the United States sometime in the year 1781 or 1782 according to the best of his recollection but cannot be certain as to the time exactly, in the month of May at Granville Courthouse in the State of North Carolina under Captain Spiva Fuller [Spivey Fuller] in the Regiment commanded by Colonel John Dickson in General Butler's Brigade in which service he continued for nine months, was then discharged at a place called Cross Creek, now called Fayette [Fayetteville] in the said State of North Carolina by Captain John Henderson who then and there gave him a certificate of his discharge which he has long since lost. That he is indigent, infirm and helpless, that he stands in need of the assistance of his Country for support. That his family consists of himself and his wife Martha Hays aged 60 years. That he is by occupation a Farmer but has no farm to occupy, nor is he able to follow his occupation being crippled in one foot and having lost the use of one arm —

I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
