The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia, Habersham County: SS

On this 17th day of September 1857, Personally Appeared before the Inferior Court of said County Amos Hill, a resident of the State and County aforesaid aged Eighty four (84) years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832, that he is the son of Isaac Hill who served in the Revolution in the State of North Carolina by turns all the time of said war, and that he the said Amos now makes this application for the purpose of drawing the pension that was due his father Isaac at his death for said services, which took place on the 20th day of October 1844 in the above named County and State. Declarant further states that his father Isaac Hill was twice married, first, about the commencement of the revolutionary war in Johnson County [Johnston County] in the State of North Carolina to Anna Harrison who died in the time of the war and the second time he married was during the time of said war to one Elizabeth Sing who has since died, and that he the said Amos is the only surviving heir of Isaac Hill by his first wife and makes his application accordingly.

He hereby relinquishes every claim whatever to a pension or an annuity except the present and declares that his name is not on the pension roll of the agency in any State. In a line that before signed up.
