Pension application of Thomas Hisle (Hisel) R5046 Nancy Hisle f17VA
Transcribed by Will Graves 4/3/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky County of Madison

On this 12th day of February 1844 personally appeared before the undersigned a Justice of the peace in and for the above written County and State Nancy Hisle a resident of the County of Madison and State of Kentucky aged ninety-five years, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th 1836. That she is the widow of Thomas Hisle who was a soldier of the revolution from the County of Culpeper and State of Virginia in the militia, she is unable to state the names of the officers he served under but she well recollects that he served three tours of three months each. She states that she has heard her husband speak of the officers he served under but from her great age and loss of memory and being much afflicted she cannot state their names at this time, but she well recollects hearing him say that he and Michael Berk¹ served under the same Captain and was in the same mess, the three tours that he was out. She recollects that she had two children when her husband was in the service. That she is now very old and infirm and very poor and have never had an opportunity before this to have the pension of applied for and at this time she is fearful that she is unable to have the proof required by the rules of the Department, but she well recollects that her husband was out in the war of the revolution and that she was at home with her children when he was out fighting for the liberty that we are now enjoying. She prays that such evidence as she has be taken in her case and a pension for 9 months service be granted her, as that is the time she knows he served. She further declares that she was married to the said Thomas Hisel [sic] on Friday in March 1777; that her husband, the aforesaid Thomas Hisle died on the 23rd of February 1832 and that she has remained a widow ever since his death, as will more fully appear by reference to the proof hereto unto annexed. She states that the marriage was in Culpeper County Virginia and his death took place in Madison County Kentucky. She says that she has raised seven children and her oldest is a son and is named Benjamin he was born in 1779, she believes that he was born in the month of February.

I Joseph Hisel a resident of the County of Madison and State of Kentucky aged 60 years state that I am the 3rd son of Thomas Hisel and that Nancy Hisel that made this declaration is the widow of Thomas Hisel and she has remained a widow ever since his death and I have never

heard it doubted but that they were legally married. Given under my hand this 12^{th} day of February 1844

I Robert Burk a resident of the County of Madison and State of Kentucky aged 56 years, State that I have heard my father Michael Burk who was a pensioner say that he served 3 tours with Thomas Hisel in the war of the revolution and was in the same mess. I have often heard them both speak of being in the same mess, given under my hand this 12th day of February 1844

I Robert Covington² a resident of the County of Madison and State of Kentucky, aged Eightyfive years state that I have been acquainted with Thomas Hisle and Nancy his wife ever since my earliest Recollection. I knew them before their marriage and ever since until his death, I was not at their marriage but from the information of the neighbors I have no doubt but that they were lawfully married, I further state that I never heard it doubted but that they were lawfully married, I know that they lived together as husband and wife until his death, and raised a family of children and their oldest son is named Benjamin, and I further state that I believe that he was a soldier of the Revolutionary War. I was in service myself from the same County that he went from, for which services I now draw a pension, although I was not in the same Regiment with him, but I know that I served two years and four months with two of his brothers that was younger than he was, but I was told that he was out as a militia man, my knowledge of Thomas Hisle and Michael Burk as men of Respectability and truth and a long acquaintance I had with them, from the information of other respectable persons, I have no doubt but that they served together as has been stated, and I know that Nancy Hisle is the widow of the same Thomas Hisle and that she has remained a widow ever since his death. I have heard her declaration read, and believe that it contains the truth. Given from under my hand this first day of March 1844.

I John Burke a resident of the County of Madison and State of Kentucky aged 53 years, state that I have often times heard my father, Michael Burke, who was a pensioner of Madison County Kentucky, state that he hauled Thomas Hisle from the hospital, or place where the sick was kept in time of the Revolutionary War, and that he, Hisle, was taken sick in the service, and had to be brought home from there, and he, Burke, was the man that brought him home from there, and I further state that Nancy Hisle is the widow of the same Thomas Hisle and has remained a widow ever since his death, Given under my hand this first day of March 1844.
