Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Sullivan County: SS

On this 4th day of April 1844 personally appeared before the subscriber a Justice of the peace Mrs. Amelia Hodges a resident of the County and State aforesaid aged Eighty-one years in September next who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838 entitled an act granting half pay and pensions to certain widows. That she is the widow of William Hodges who was a soldier in the Regular service in the Virginia Line in the War of the Revolution. That her husband the aforesaid William Hodges entered the service in the year 1776 for three years under the following named Officers Captain Henry Erwin Tooley the rest of his officers she at this time cannot recollect but well recollects of hearing her husband say that he was in the battles of Brandywine [September 11, 1777], Germantown [October 4, 1777], and Long Bridge [December 9, 1775] for further testimony she refers the Department to the Virginia Rolls and the testimony hereunto annexed. She further declares that she was married to the said William Hodges on the 24th day of June 1782 that her husband the aforesaid William Hodges died on the 24th day of November 1836, that she was not married to him prior to his leaving the service but the marriage took place previous to the first of January 1794 viz. at the time above stated.

State of Tennessee Sullivan County: SS

On this 4th day of April 1844 personally appeared before the subscriber a Justice of the peace for said County Mr. Abraham Grigg a resident of the County and State aged 54 years in September next and after being duly sworn according to law doth on his oath make the following affidavit That he is well acquainted with Mrs. Amelia Hodges who resides in this County and was well acquainted with her husband William Hodges up to the day of his death and knew them to live together as man and wife from affiants first recollection and were always understood as such in the neighborhood. Affiant further declares that he has had frequent conversations with the aforesaid William Hodges before his death in relation to his services in the war of the Revolution. Affiant heard him the aforesaid William Hodges say he entered the service in the town of Norfolk Virginia in the Virginia line for three years and had the promise for land. Affiant further declares that it was believed in the neighborhood where the aforesaid William Hodges lived that he was in the war of the Revolution and never heard the same doubted. Affiant further declares that he heard the aforesaid William Hodges say that he was stationed at the town

of Norfolk¹ at the time the British laid the city in ashes.

On this 4th day of April 1844 personally appeared before the subscriber a Justice of the peace for said County Mr. Roland Hodges a resident of the County and State aforesaid aged seventy-four years and after being duly sworn according to law doth on his oath make the following Affidavit. That he is well acquainted with Mrs. Amelia Hodges and was well acquainted with her husband William Hodges up to the day of his death and knew them to live together as man and wife from their marriage which took place in 1782 and the aforesaid William and Amelia Hodges were recognized as man and wife in the Neighborhood where they lived up to the time of his the aforesaid William Hodges death. Affiant further declares that he well recollects of the aforesaid William Hodges being from home in the service in the War of the Revolution and always understood that the aforesaid William Hodges was in the Regular service and served as such in the War of the Revolution. Affiant further declares that sometime before the close of the war of the Revolution Affiants father was apprised of the aforesaid William Hodges home for the purpose of medical aid.
