Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Alabama Lawrence County: SS: Before me Henry A. McGhee Judge of the Probate Court of said County, began and held in and for said County on the 4th day of August 1851 personally appeared in open court Samuel W Wallace, who is administrator of the estate of William Hodge deceased, and who being duly sworn according to law doth on his oath make the following declaration, for the use and benefit of the surviving children of the said William Hodge hereinafter named, to wit, John Hodge, Moses Hodge, Jane Hodge, who intermarried with Jonathan Fuller, Elizabeth Hodge, who intermarried with David Wiger, and Frances Hodge who intermarried with Samuel W Wallace, (declarant), in order to obtain for the aforesaid children the benefits of the provisions made by the Acts of Congress of the 7th of June 1832, and the 15th of May 1828; that the said William Hodge was a private in the War of the Revolution and served in the State Troops and militia of South Carolina for a period of upwards of 2 years in tours of different direction is in Colonel Brandon's [Thomas Brandon's] Regiment, and in other tours not known to declarant, nor the names of the officers. That the said William Hodge died on the 14th day of April 1843 in the said County of Lawrence in said State of Alabama: and that the wife of said William Hodge died several years previous to said William's death, in the County of Morgan in said State of Alabama, the year not recollected; that in this application is made for the purpose of obtaining the arrears or unclaimed pensions due said William Hodge under the several acts aforesaid.
