Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The United States of America State of South Carolina Newberry District

On this 22nd day of May 1847 personally appeared before me one of the magistrates in and for the district and state aforesaid Mrs. Hannah Hudgens widow aged eighty-two years a resident of the district of Newberry who being first duly sworn according to law doth on her oath make the following declaration in order to be entitled to the benefit of the 3rd section of the law of Congress of the 4th of July 1836, and the acts of Congress of July 7th 1838 – 3rd March 1843 and 17th of June 1844 in relation to the granting half pay and pensions to certain widows. That she is the widow of Ambrose Hudgens who was a private volunteer soldier in a militia Company raised in Caswell County North Carolina and that he served three tours of duty of three months each and that it was near the close of the war when he obtained his last discharge during the war of the revolution and served in the same under arms at least nine months during this time he served in North and South Carolina and was at the engagements of Kings Mountain, Ninety Six and Camden under Generals Green [Nathanael Greene], Williams and Gates [Horatio Gates] deponent does not remember the name of the Captain under whom her husband served. Deponent having heard her husband state these facts has reason to believe the same. Deponent says her said husband having served his time out was regularly discharged and was discharged the last time about the close of the war. Deponent saith that she was married to the said Ambrose Hudgens on the 15th of January 1781 in an interval between two of his terms of service by one Gabriel Davy a magistrate and that the said Ambrose Hudgens died on the 3rd day of November 1822. Deponent says her husband the said Ambrose never did receive any pension from the General State Government but that a pension of \$30 per annum was granted to her on account of the services of her husband in the revolution as above stated by the Legislature of South Carolina in December 1844 and in support of this her claim she submits the annexed proof.

State of South Carolina Newberry District: On the 22nd day of Me 1847 personally appeared before me Mrs. Hanna Hudgens widow of Ambrose Hudgens and makes oath that the oldest child of Ambrose Hudgens and herself is William Hudgens and that he was born on the 4th day of May 1782 and that Sarah the next oldest child of the said Ambrose and herself was born on the 9th day of April 1784, Fanny, Nelly, Mary, Austin, Ambrose, Hannah, Josiah, John, Stephen, Charlotte, and Ancell were all children of Ambrose Hudgens and herself and that they were born in the manner in which they were named Fanny 24 April 1786, Nelly December 22 1788, Mary

January 8th, 1791, Austin December 2nd, 1793, Ambrose November 16, 1795, Hannah September 18th, 1797, Josiah March 21st 1790 9, John January 2nd 1801, Stephen 31 June, 1802, Charlotte Me 11, 1805 and Ancell June 14th 1807, and that she has never married but one time.

[fn p. 27: On May 1, 1847 in Newberry District, SC, Thomas Denson, 183, a pensioner for his service in the Revolutionary War gave testimony that he served with Ambrose Hudgens in a militia company but he doesn't recall the locality; that Hudgens served as a private at least 9 months and was honorably discharged at Ninety Six he thinks close to the end of the war. He signed his affidavit with his mark.]
