Pension application of John Ingram R5483 Ruth Ingram f43SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 5] State of Georgia Cherokee County

On this 5th day of March 1847, personally appeared before the Elias E. Field one of the Judges of the Inferior Court of the County aforesaid; Mrs. Ruthe Ingram, a resident of the same County and State, aged as near as she can calculate Eighty nine years (who I certify is unable by bodily infirmity to attend in open Court) who, being first duly sworn according to law, doth, on her oath, make the following declaration in order to obtain the benefit of the third section of the act of Congress passed July 4th 1836:

That she is the widow of John Ingram, who was (as she believes a private) in the War of the Revolution, that they then resided in Union District in South Carolina, she cannot state the circumstances of his entering the service, but he served under Captain John Putnam, in Colonel Brandon's [Thomas Brandon] Regiment, (of militia she believes). She cannot at her advanced age, state with precision the date of his entering the service or the time of his leaving, or any of the other Officers under whom he served, thinks most or perhaps all of his service was performed in South Carolina, she does not know as to his being in battles, but thinks he was in the battle at Kings Mountain [October 7, 1780] & at Cowpens [January 17, 1781], thinks he was a volunteer. He had a discharge, but it is long since lost. She knows of no documentary evidence to sustain her claim, but is informed that such things are recorded in Columbia South Carolina where she hopes something may be found. She further declares that she was married to the said John Ingram in Union District in the State of South Carolina on the 19th day of July after she was twenty-one years old, which from calculation would make it in the year 1778; that her husband was absent from her much in time of the war, at the close of which service she had two children; she has no family record now, but that one kept by ____ which her son ____ took with him, he now resides in __ County and perhaps it may be had, She was married by a Baptist Preacher by the name of Crowder. She further declares that her said husband the aforesaid John Ingram died in Hall County in the State of Georgia on this sixteenth day of September 1728 and that she has remained a widow ever since that period, as will more fully appear by reference to the proof here with sent.

South Carolina Pickens District: Mrs. Abarilla Wilbanks¹ whose character for veracity and respectability is good: appeared personally before me and made oath in due form of law, that she was well acquainted with John & Ruth Ingram, before, during and after the Revolutionary War. They then resided in Union District South Carolina where deponent also resided. They were near neighbors -- John Ingram was a Messmate of deponent's husband in the service of his Country in the War of the Revolution and bore the character of a good Soldier. She was not present at their marriage but recollects to have heard of it and that they were married by Parson Crowder a Baptist Minister who supplied Fair Forest Church she knew them both before and after marriage but cannot recollect the date at which the marriage took place but is sure it was previous to the service of Ingram no doubt about 1778 as stated by Mrs. Ingram. They had at the close of the War one child or more. Her maiden name was Ruth White. She has heard that John Ingram is dead and that his widow Ruth Ingram now resides in Cherokee County Georgia.
