Pension application of Teresha (Terisha) Johnson R5667 Transcribed by Will Graves f14VA 1/4/14

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of Tennessee Henderson County: Court of Pleas & Quarter Sessions August Term 1832
On this 16<sup>th</sup> day of August 1832 personally appeared in open court before the Justices of the Court of pleas and quarter sessions for the County and state aforesaid now sitting Terisha Johnson a resident of the County of Henderson and State of Tennessee aged about seventy years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service of the United States some short period anterior to the Battle of Guilford Courthouse in 1781 [March 15, 1781] as a Drafted Militia Private and served for the space of one month having been wounded in the right leg just above the ankle by a musket or Rifle Ball in the battle of Guilford. After receiving this wound this Declarant was permitted either to repair to the Hospital or go home, he preferred the latter and returned home. This Declarant states that as well as he now recollects the name of his Colonel was Robert Mumford or Munford [Robert Munford] – his Captain was \_\_\_ Brown [John Brown] and his Lieutenant's name was Joshua Davis.

This declarant states that the Regiment to which he belonged whilst in the Revolution was from the County of Mecklenburg in the State of Virginia in which County and state this Declarant was born and raised – this Declarant states that he was in no other engagement except the Battle of Guilford – the commanding General of the Americans was General Nathaniel green. This Declarant states that he marched from the said County of Mecklenburg into North Carolina and joined the American Army some short period before the arrival at Guilford Court House. This Declarant further states that as well as he now recollects that there was a Lieutenant General Lawson [Robert Lawson] of the Regular Army in the Battle of Guilford and perhaps 2<sup>nd</sup> in Command but of this he is not positive. The Commander in Chief of the British Army was Lord Cornwallis. Colonel Tarlton [Banastre Tarleton] commanded the British Cavalry. The Americans retired from the field although the British was supposed to have lost the greatest number of men. This Declarant hereby relinquishes every to a pension or annuity except the present and declares that his name is not on the Pension Roll of the Agency of any State. This Declarant further declares that he has no Documentary evidence and that he knows of no person whose testimony he can procure who can testify to his service.
