[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Franklin County: Court of Pleas & Quarter Sessions June Term 1833 On this 11<sup>th</sup> day of June 1833 personally appeared before the Superior Court of law for the County aforesaid Moses Joiner resident in the County of Franklin and State of North Carolina aged seventy-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 7<sup>th</sup> day of June 1832. That he was at the time he entered the Service of the United States a resident of Southampton County State of Virginia, that he was drafted as well as he recollects about the year 1776 but for [one or more indecipherable words] refers you to the Rolls of Virginia in the two months service and was placed in the 3<sup>rd</sup> division under Captain Whitehead, <sup>1</sup> who was commanded by Colonel Duvall, this tour of two months he served at Portsmouth. The 2<sup>nd</sup> tour of two months he served at Suffolk under the same Captain and Colonel. The 3<sup>rd</sup> Tour of two months at Colonel Sanders in [indecipherable word]<sup>2</sup> County under same Captain. The 4<sup>th</sup> tour of two months he was stationed most of the time at Neads Mill [probably Mead's Mill] and from there he was marched backwards & forwards on the Eastern coast for the protection of the inhabitants until the expiration of his Tour under same Captain. The 5<sup>th</sup> tour of two months he went out under Captain Elias Herring he marched to one Godwins on the Western Branch where he was stationed for some days from thence he marched to Williamsburg and was there at the Surrender of Corn Wallice [Cornwallis, October 19, 1781] – at which time he was discharged by Major Boyakin [Boykin?] verbally – That himself with many others requested him to give them a written discharge but he told us that being discharged in that way was quite sufficient as there would be no further use for us. - That sometime after that time he removed to Franklin County North Carolina where he has resided ever since – say about forty years – he further states upon his oath aforesaid, that he has no other means of proving his services other than by his own oath. He hereby relinquishes every claim whatever to a pension or an annuity, and declares that his name is not on the pension Roll or any agency in any State.

[p 22: On October 22, 1850 in Franklin County North Carolina, William Joyner gave testimony that he is the son of Moses and Honor Joyner; that his parents always told him he was born in Southampton County Virginia; that they were married by one Barrow a Baptist preacher; that his (affiant's) age is about 60 or 61 years; that he had a living Brother and Sister older than himself; that his father and mother lived together as man and wife up to July 16, 1836 when his father Moses Joyner died; that his father was a pensioner at the time of his death; that his mother continued to live without remarrying until March 1, 1840 when she died. He signed his affidavit with his mark.]

[Locky Wester and Daniel Wester gave testimony in support of that given by William Joyner in his affidavit transcribed above.]

[Veteran was pensioned at the rate of \$33.33 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 10 months in the North Carolina [sic Virginia] militia.]
