Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Personally appeared before me on this the 24th day of September A.D. 1855 Francis Jones and Elizabeth Jones both residents of the County and State aforesaid who having first been duly sworn according to law doth on their oath declare and say that they are the children of the identical Cooper Jones who served in the Revolutionary War, that their father the said Cooper Jones never received any compensation for said service to their knowledge other than that as now ascertained from the Records of the Comptroller's office of this State -- that they have no other evidence of the time of his enlistment or discharge than by reference as aforesaid -- that they are the only surviving children of the said Cooper Jones who died in the month of October 1797 -- that they nor either of them have never applied for any pay or compensation nor authorized any person to do so for them on account of the services of their father until now and they hereby relinquish every claim whatever to a pension or annuity except the present. John Jones being duly sworn on the holy Evangelist of Almighty God states as follows -- that he is now 75 years of age -- that he was born and raised in this County and has resided here all his life -- that he is a nephew of Cooper Jones and was raised within a mile of his residence -- he Cooper Jones lived in this County and died when the said John Jones was a boy about seventeen years of age -- I have heard him tell of his having served as a soldier in the old war -- He was the father of Francis Jones and Elizabeth Jones the same whose names appear to this paper I have no doubt of the fact of their being his lawful children when Cooper Jones my uncle died he was possessed of Real Estate and the said Francis and Elizabeth Jones had a part of it as his heirs.

In corroboration of the truth of the foregoing statement the said John Jones have here to apply to his signature.
