Pension application of Josiah Jones¹ R5722

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, Anderson District

On this fourth day of March 1833 personally appeared in open Court before the Judge of the Court of Sessions and Common Pleas of said State for said District now in session Josiah Jones of the State & District aforesaid who being duly sworn according to law doth on oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832 --

This Deponent was born in Cumberland County Virginia about the year 1752 -- as well as he recollects -- having no record of his age -- he entered the service about the year 1775 as an enlisted Soldier -- and Captain Smith the recruiting officer -- and given up by him to Captain Cavill's [Samuel Jordan Cabell of the 6th Virginia Continentals] Company -- Colonel Buckner [Mordecai Buckner of the 6th Virginia Continentals] -- General Lewis [Brigadier General Andrew Lewis]. Served two years under those officers but in no engagement -- after that he volunteered with a company all of whom deserted but three to go on an expedition to Stono -- under Colonel Hampton [Andrew Hampton], General McDowell [Charles McDowell] -- in one engagement upon Packolet [sic, Pacolet River] near the line of North & South Carolina -- with the British & Tories he served three months in that tour -- he again volunteered under Captain Kirkendall [Captain Abraham Kuykendall] in the Light Horse merely for the purpose of scouting through the Country served forty days -- he served as an armorer -- repairing arms, making swords, and shoeing horses for two years under General McDowell -- never remunerated for his service as armorer -- he volunteered to go against the Cherokees under Captain Watson -- in service 26 days -- This Deponent believes himself to have been in the service more than two years -- he says he had a written discharge from the regular Service -- which was burnt in his house with all other papers -- he has never received any compensation for his Services -- knows of no direct proof of his Service which he can offer but what accompanies this document -- he removed from Virginia at first to Burke then to Rutherford North Carolina then to Greenville South Carolina -- after that to Anderson where he has been living for 34 years -- Sworn to and subscribed this 4th day of March 1834 -- He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the Pension Roll of any State -- Sworn to and Open Court.

Personally appeared before the me Josiah Jones and made oath to the following fact the explanation of his original application for the benefit of the Act of Congress June 1832 made in open Court 4th March 1833 This Deponent has already stated his age and birthplace although the original record of the latter has not been preserved yet when twelve years of age he was informed of his age by his mother and since that time has preserved the account --

In his original application he produced no clergyman to certify for him because he believed it unnecessary when direct proof could be had. He cannot now produce any proof of the time of his enlistment or its duration -- as he has no knowledge of any other human being now alive than John Looney who served with him during that time -- His enlistment must have been in June 1775 as he recollects distinctly that it was a short time before the battle at Bunkers Hill -- at this time he lived in Virginia His three months tour was commenced in July 1780 living then in Rutherford County North Carolina --

His tour under Captain Kirkendall was in January 1778 --

By reason of his old age and consequent loss of memory he is not able to state more definitively than he has done the periods of the war in which he served.

Petition of Josiah Jones praying for a Pension Pensions Whitner

To the Honourable the President and Members of the Senate & The Speaker and Members of the General Assembly of South Carolina The Petition of the subscriber humbly Sheweth

That your Petitioner served Two years in the Sixth Regiment of Regulars in the Virginia Line, after the service there was ended he moved to No. Carolina & Served different Tours in the Militia of that State, & being a Black Smith by Trade was the principal part of Three years employed in making Swords & Shoeing Horses for the Troops, for which he never rec'd anything like an adequate compensation & having experienced thro' life many Misfortunes and above all the most distressing of any, almost the entire loss of sight & having no property or Relations from Whom he can claim any assistance, he is compelled very Reluctantly to throw himself on the clemency of his Country in hopes they will grant him such Relief as they think proper and as in duty Bound he will ever pray.





Mr. Josiah Jones says & I have no doubt that it's true that he was in Under the Command of General Charles McDowell of No. Carolina Immediately on the line between the two States probably a part of the Troops in each State when Capt. Dunlap [James Dunlap] of the British Mounted Infantry made a charge on him the troops under McDowell kept the ground, ⁵ & next morning, pursued Dunlap nearly twenty Mile[s] in the South almost to Where he was then quartered he further says of the truth of which I have no doubt that he served frequently under Capt. Andrew Hampton of Rutherford County No. Carolina who to my own knowledge done a great deal of duty in So. Carolina.

They therefore respectfully recommend that the prayer of the petitioner be not granted.
