Pension application of John Kelly [Kelley] R5845

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina District of Richland: On this twenty ninth day of July in the year of our Lord 1851 personally appeared before the undersigned Judge of the Court of Ordinary in open Court, now sitting, Hampton H. Kelly a resident of the District of Richland in the State of South Carolina, aged fifty-one years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832: That he is the son & heir at law of John Kelly deceased who entered the service in the war of the Revolution and served under the following named officers as herein stated: That said John Kelly deceased as this Deponent has been informed and verily believes was at the time of said war living in what is now Fairfield District in this State and towards the close of the said war volunteered as a private horseman in the company commanded by Captain Jacob Barnet [Jacob Barnett] in the Regiment of Horse commanded by Colonel Henry Hampton in Sumter's [Thomas Sumter's] Brigade State Troops, in which capacity he served as this Deponent believes not less than ten months: That after the close of said war he continued to reside in said District of Fairfield and died at an advanced age on the 19th day of January in the year of our Lord 1842: That his said father John Kelly deceased who served as aforesaid has frequently told this Deponent of his having been in the service and in the battles at Eutaw [Eutaw Springs, September 8, 1781]¹ King's Mountain [October 7, 1780],² & Cowpens [January 17, 1781]: That he left no widow this Deponent's mother having died previous to his said father: That his said father refused in his lifetime to make application for pension because he alleged that he had plenty [to] do him his lifetime.

That after his father's death and at the sale of his father's property this Declarant's brother Frost Kelly who has since moved to the State of Mississippi bought an old trunk containing the old "papers of his said father" and a portion of his said father's horseman's uniform which he had in his lifetime declared was part of that which he wore in said service in said war. He hereby relinquishes every claim whatever to a pension for his said father services except the present and declares that his said father's name is not on the Pension Roll of any agency in any State. In proof of these several allegations this Declarant submits the accompanying evidence.

State of South Carolina District of Richland: Personally appeared before the undersigned an acting Magistrate in & for said District, Theophilus Wilson⁴ who being duly sworn according to law doth on his oath state. That he is now 86 years of age & has from boyhood lived in Fairfield District South Carolina and is now a pensioner of the State of South Carolina on account of his Revolutionary Services: Deponent had a father & three brothers in the American service: That John Kelly the father of the present Hampton H. Kelly was then a resident of said District and Deponent knew him during the war and saw him in service under Colonel Hampton attached to the Brigade of Cavalry commanded by General Sumter and that John Stewart who also belonged to his same neighborhood with this Deponent was in the same service with said John Kelly: That the time of service for which this Brigade was out was generally considered 10 months. That after the war said John Kelly lived in deponents neighborhood until his death about 9 years ago: That this Deponent is entirely disinterested in any amount which said son H H Kelly may recover on account of his said father's services.

Sworn to October 12th 1786
