That Said Rawls has since I wrote this died the Said statement remained in my hands until 1846 when I [] led it to C.H.Blood

State of Georgia Decature County

Be it remembered that on this 15th day of December 1846, personally appeared Rev. John W. Mann, and made the following Declaration in Open Court before the Superior Court of said County (now sitting in said County) in order to obtain for the children of William Kemp deceased the benefit of the provisions of the Act of Congress of June 7th 1832 and all other Acts, said Kemp was entitled to at the time of his death, That he is the Administrator of said Wm Kemp (deceased) late of Decature County Geo., that this Deponent was intimately & personally acquainted with said Kemp since 1810 That he married the daughter of said Kemp in 1811, in Washington[? or Wilkinson] County Georgia, that this deponent had been much in the Company of his Father in Law and often heard him speak of being a Soldier in the Geo and SC Militia[?] and that he enlisted in Georgia in the Continental Establishment (as this deponent believes) that from his Words[?] and Narrative[?] of his life, he has learnt the following That said[?] Kemp was born in the state of N.C. that his father died when young. His mother married a man by the name of [unreadable]² and settled in Rugleys Mills in Kershaw District S Carolina [?] that when the Revolutionary War broke out said Kemp was at his sisters [?] in Wilkes County, Georgia that [unreadable] to the Georgia troops that deponent believes him to have been in Captain Dooleys Company under Habersham and Clark said Kemp returned home to his father in laws in Kershaw District SC that he believes him to have been in Col. Kershaws³ Regt. that he has heard him speak of serving under Gen. Elijah Clark & Col Twiggs, McIntosh[?] Col. Marshalls⁴ Regt. and of one Capt. Nettles⁵ that this deponent is very certain that said Kemp was a soldier to the close of the war, and had enlisted to serve to the end of the same, that said Kemp said he served about seven years in the Revolutionary War, of which fact this deponent is fully satisfied.

That after the Close of the Revolutionary War said Kemp married the widow Kittles in Washington Co. Geo. about 1791 – That the Said William Kemp & Mary his wife had five Children born in lawful wedlock of whom two are living (only) to wit Mary Mann wife of this deponent and George W. Kemp both residents of Gadsden Co. Fla. that he presents to the Court his family bible containing the records of his family together with his parents etc.[?]

The record Commences as follows to wit

Rebecca Mann mother of John W Mann was born Nov. 19th 1765
William Kemp father of Mary Mann was born Jan. 5th [or 15th] 1751
Mary Kemp Consort of Wm. Kemp was born March 5th 1759
John W. Mann (this deponent) was born February 8th 1785
Mary Mann Consort of John W. Mann was b. March 23, 1785 (that was the third child of his parents,) the said Wm. & Mary Kemp[?] and then follows the births of Twelve children sons & daughters of John W. Mann and his wife Mary (formerly Kemp)

Deaths as Stand recorded in family record to wit William Kemp father of Mary Mann departed this life July 21st 1834 Mary Kemp Consort of William Kemp departed this life December [?] 1834 Arnold Mann father of this deponent departed this life August 1st 1819[?] Rebecca Mann Consort of Arnold Mann departed this life February 1836

That the foregoing record is correct, and as it stands stated in his family bible, that it was copied by his request in the handwriting of Geo. T. Codding [?] into his large family bible from some leaves of paper sewed into a small family bible, and that the same was transferred by copying as aforesaid some 4 years since.

That said Wm Kemp died at the house of deponent in Decature County Geo. on the 21st day of July, 1834 -----

That Said[?] Kemp moved to Wilkinson Co Geo. about 1815 and to his[?] house in 1831, that this deponent often heard said Kemp spoke of seeking[?] a pension for his services in his life time, but that his mind was impaired very much, and that no attempt was made, and that said Kemps name is not on the pension roll [] any State at this time. That said Kemp was married to Polly Cattle [Mary Kittles] in Washington Co. Geo. previous to 1794. that his widow the said Polly died at his house December 1834 That I 1843 I was informed by Mr. Wm Rawls ([can't read]) Gadsden County Fla that he was acquainted with said Wm Kemp while he was in the Revolutionary Army. I applied to Hon. David Levy Rep. who advised me to call on Mr. Isaac [Sunderson?] in Quincy and if I could find any living proof

Be it remembered that on this 15th day of December, 1846, in Open Court before the Superior Court of said County now seting____ personally appeared George W. Kemp of Gadsden County Florida and made oath in due form of law, that is is the lawful Son of William Kemp (deceased) late of Dacature County, Georgia, that his father the said Wm Kemp was a revolutionary soldier, that from his Statement, and from his oft conversation with the soldiers with whom he served (in his lifetime) this deponent is satisfied that his father the said Wm Kemp was a revolutionary soldier, and served seven years in the War of the Revolution ___ Among the officers he has heard his father speak of serving with are the names of Genl Elijah Clark, Habersham, McIntosh[,] Kershaw, Capt Dooley, Nettles, Horton, Twiggs[,] Marshall & this Deponent cannot remember the rank each officer held at the time, but has heard his father speak of the battles he was in, in Georgia, that he does not know that his father was any other than a private soldier__ that his fathers first and last[?] service was performed in Georgia as this deponent has heard and believes, but he has heard his father speak of doing much service in South Carolina when the Georgia troops were driven from the state by the Brittish & Tories

That his father was born in (N.C.) that his father died when the said Wm. Kemp (father of this deponent) was young and his Mother married a man by the name of Sunderson and Settled near Ruglys Mills Kershaw District (SC) that after the close of the War the said Wm Kemp married and settled in Washington Co Geo[rgia] about 1791 and removed to Wilkinson Co Geo about 1815 that he continued to live in Wilkinson Co Geo till about 1831 when his Father and Mother moved (to their Son-in-laws) Rev. John W. Mann's where they lived till 1834 and both died in said County at said John W. Manns house in Decature Co Geo That his Father the said Wm Kemp died on the 21st day of July 1834 and his Mother Polly (Mary) Kemp died in December following, that this deponent had four brothers and sisters all of whom died young except Mary Kemp the present wife of John W. Mann__ That this Deponant and Mary Mann are all the children living of said Wm Kemp that they now reside in Gadsden County Fla. that Said John W. Mann is the Adr. of said William Kemps Estate and duly authorized to settle the same.
