Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this day personally appeared in court before the Worshipful County Court, now in session, Isaac Bartley, son & heir at law, and Administrator of the Estate of his Father, William Bartley deceased, a Soldier of the Revolution, who is due you & Solomon form of law, doth, on his oath declare that William Bartley was a Soldier in the War of the Revolution, that he Enlisted in Orange or Guilford County North Carolina, but, under what officer, he is unable to say, that he served to the close of the War, & was honorably discharged, that his discharge is lost, that the said William and Sarah Horsey his widow, were married about the year 1770 or 1771 in North Carolina, that they had three children – that he is the third child, & that he is now in the 80^{th} year of his age – that the said William Barclay died about the year 1818 and his widow Sara in the year 1843 he prays pension in right of said several under Act of 1836.
