[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Delaware County of Sussex

I Hugh King oldest son & heir at law of John King deceased do upon my oath declare and testify that to the best of my knowledge and belief the said John King of Delaware did enlist in the year 1776 or 7 for the term of during the War and served in the Regiment, No. Unknown under the command of Col. William Washington of the Continental line, and that he continued in the service until the War ended. I further declare that I have never received a warrant for the Bounty Land promised to the said John King on the part of the United States; nor do I believe that he ever received it, or transferred his claim to it in any manner whatsoever: Therefore Know all men by these Presents, that I Hugh King aforesaid do hereby constitute and appoint Vaspasian Ellis of Accomack Virginia to be my true and lawful attorney for me and in my name to demand and receive of the Secretary of War of the United States a warrant for the quantity of land due to me as aforesaid; and my said attorney is hereby authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes above expressed.



State of Delaware New Castle County SS

Before me Thomas McDowell Notary Public of the State of Delaware duly commissioned & qualified and legally authorized and Residing at [indecipherable name]² in said State personally appeared Major Peter Jacquett [sic]³ to me well known who being duly sworn deposeth and saith that he was well acquainted with John King of Sussex County in the State of Delaware, that he was a soldier in the Army of the Revolutionary War, & served in the Delaware Regiment, that at the Battle of Camden on 16 August 1780 the said line was reduced from eight to two companies of ninety-six men each, commanded by Capt. Kirkwood [Robert Kirkwood] and this deponent, and were attached to Col. William Washington's Legion in the Virginia line, that the said John King served under Col. Washington until the close of the war as a soldier.

Before me Peter Hall a Justice of the peace in & for the County of Sussex in the State of Delaware, personally appeared Hugh King Administrator & one of the Children & heirs at Law of John King deceased late of said County formerly a Soldier of the Delaware line in the Army of the Revolution which said Hugh King is a Citizen of said County & known to me as a person of good repute & entitled to credit who being first duly sworn does on his oath say that he has always heard & understood from his father John King deceased that he enlisted in the Delaware Regiment in the early part of the Revolutionary War for the Term of during the War & continued in service to the end of the War, & was honorably discharged, that said John King died on the 25th day of February 1832 & that a short time prior to his death his said father was about to apply for the benefits of the Act of Congress passed May 15th 1828 and for that purpose of obtaining the deposition of Major P. Jaquett proving his services to the end of the War as aforesaid – but that he died shortly thereafter & no application was ever made for a pension – that about 2 or 3 months ago the said deposition of Major Jaquett was forwarded with the application of this deponent to the office of the Secretary of War for the purpose of obtaining the Bounty Land due from the United States to this deponent & the other heirs of said John King – that said application was granted and a Warrant for 100 Acres thereupon issued numbered 1951 to this deponent & the other heirs of said John King which has been surrendered to the Secretary of the Treasury for Scrip – that this deponent does not know whether the said John King did or did not receive the bounty of \$80 promised by the Continental Congress nor does he know what pay if any he ever received nor what became of his discharge. John King of __ in the County of Essex in the State of Delaware has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain __ 's Company, in the __ regiment of the Delaware line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing
