Pension application of Edward Bass R599 Transcribed by Will Graves f19NC 7/16/08 rev'd 8/30/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Ashe County: Court of Pleas and Quarter Sessions November Term 1834 On this 10th day of November personally appeared Edward Bass a resident of said County before the Court aforesaid aged seventy-four years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 7th June 1832. That he entered the service of his Country as a drafted man when he lived in Dobbs County and State of North Carolina – which County has been since called Lenoir under Captain Benjamin Harrison and – marched to Kingston [sic, Kinston] and was stationed there for two months and was then marched to the North & went on through Tarborough and got near to Halifax and we met the French Army that was going to the South and we then were turned back with that Army and I was put under Captain __ Quinn a Continental officer & marched to Kinston and staid there two months more we were then marched to Fayetteville and laid there two months and then marched for the South against the British Army that was stationed at Savannah and we marched on for that place until we heard of General Gates [Horatio Gates] being defeated by the British & Tories & I was then discharged and came back and lived in Chatham County, after being in the Army for eight months & three weeks, sometime after this I was again drafted for six three months under Captain Litterell [Luttrell] of Chatham County – and went on to the Barracks and was stationed there for two weeks. I then became unwell & hired one Jacob Jones as a substitute, and gave him a horse saddle & bridle worth \$70 (& two half [indecipherable word, looks like "Joes"]² and I got a discharge for the six months, and I then went home. After this I was again drafted for three months and myself and six other men hired one William Maler for twelve months and I was never called into service any more. I was taken by a party of Tories at home and they destroyed my discharges, and that he has no documentary nor any other mode of proving his services, he don't know of none of his associates in the revolution that is now living. He hereby relinquishes every claim whatever to a pension or annuity, except the present and he declares that his name is not on the pension Roll of any State or agency.

[Calvin Jones, a clergyman, and James Maxwell gave the standard supporting affidavit.]

And the following interrogatories was put to the applicant and these are his answers --When and in what year were you born? Answer I was born in Dobbs County now called Lenoir in the year of our Lord 1760 from the best of information and the record of the family of ages was burnt in the house of my Father – that he has now no record of it --

Where were you living when called into service: where have you lived since the Revolutionary War

and where do you now live? Answer I lived in Dobbs & Chatham Counties when called into service, and that he lived in Chatham twenty years after the war then moved to Surry County in this State and lived there about twenty-two years, & then moved to Ashe County where I have lived here seven years How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom? Answer I was drafted every tower [tour]

State the names of some of the principal officers who in the army with you. Answer Of the name of the Adjutant of the French Army was Shike [?]³ and I believe there was a General in Army by the name of Malbery [?] [probably an attempt to name Francois Lellorquis Marquis de Malmady (also Malmedy, Malmèdy)]

State of North Carolina, Ashe County

This day came Edward Bass personally before me the undersigned one of the acting Justices of the Peace for said County, and makes oath in due form --

That he believes that in making out his Declaration for the purpose of getting a pension that he made a mistake by stating that he served as a militia man, and that he should have stated himself as a State's troop, that he well recollects that he was Balloted for as it was then called to serve for nine months and that he served as stated in the Declaration which is now on file in the Pension office of the United States and that he got a full discharge from Governor Caswell [Richard Caswell] of North Carolina and that the Tories took it from him shortly after he came home from the service and that the reason that he did not sent [sic, send] on this as he is amended statement to his former Declaration sooner is that he has been trying to find some person that he could prove his services by, but his old age and want of money has as yet prevented him from being able to find any person that he can prove his services by, that he now lives at least 300 miles from the parts of Country where he lived when called into service and having no friends that will go that distance to see if the testimony can be procured, to all the other statements made in the Declaration that is now in the Pension Office at Washington City he believes to be true – and from his age and consequent loss of memory he knows of no other facts that is believed to be material, and hopes that this may be received as an amendment to his former Declaration.
